Municipal Solid Waste (MSW) Interstate Flow in 2008
August 26, 2010
Prepared by the NEWMOA Solid Waste Metrics Workgroup²

State environmental agencies in the Northeast have a responsibility to monitor and manage solid waste (MSW) disposal capacity. To help fulfill this responsibility, all of the NEWMOA-member states gather data from the MSW facilities that they regulate on their waste imports, and most members collect data on waste shipped out-of-state in order to assess disposal capacity and to measure recycling and other waste diversion activities. Starting in 2000, the NEWMOA members began to share data and prepare reports to characterize the flow of MSW among the states in order to better validate the information they collect. The director of the solid waste program in each NEWMOA-member state appointed at least one representative to serve on a regional Solid Waste Metrics Workgroup. The purpose of this Workgroup is to oversee and manage NEWMOA's MSW data collection and analysis and preparation of this presentation. By working together, the Workgroup members have improved the accuracy of their state data.

This presentation presents the results from NEWMOA's 2008 data collection and analysis efforts through a series of figures that summarize both state-specific and region-wide MSW disposal data.³ Its purpose is to help inform MSW policy and program development of the NEWMOA-member states. NEWMOA has performed this analysis annually starting with calendar year 1999 data. In 2006, NEWMOA decided to collect and analyze MSW disposal data every other year. This Report presents figures for the calendar year 2008 data and compares the results with 1999 – 2006 data.

NEWMOA's Workgroup members provide summaries of the MSW data they collect from facilities to NEWMOA staff for analysis. The staff reviews the data and works with Workgroup members to resolve any discrepancies. A typical type of discrepancy is a situation where transfer facilities in State A indicate they sent X tons of MSW to disposal facilities in State B, whereas disposal facilities in State B report they received Y tons that originated in State A. Unless noted otherwise, the figures presented below are

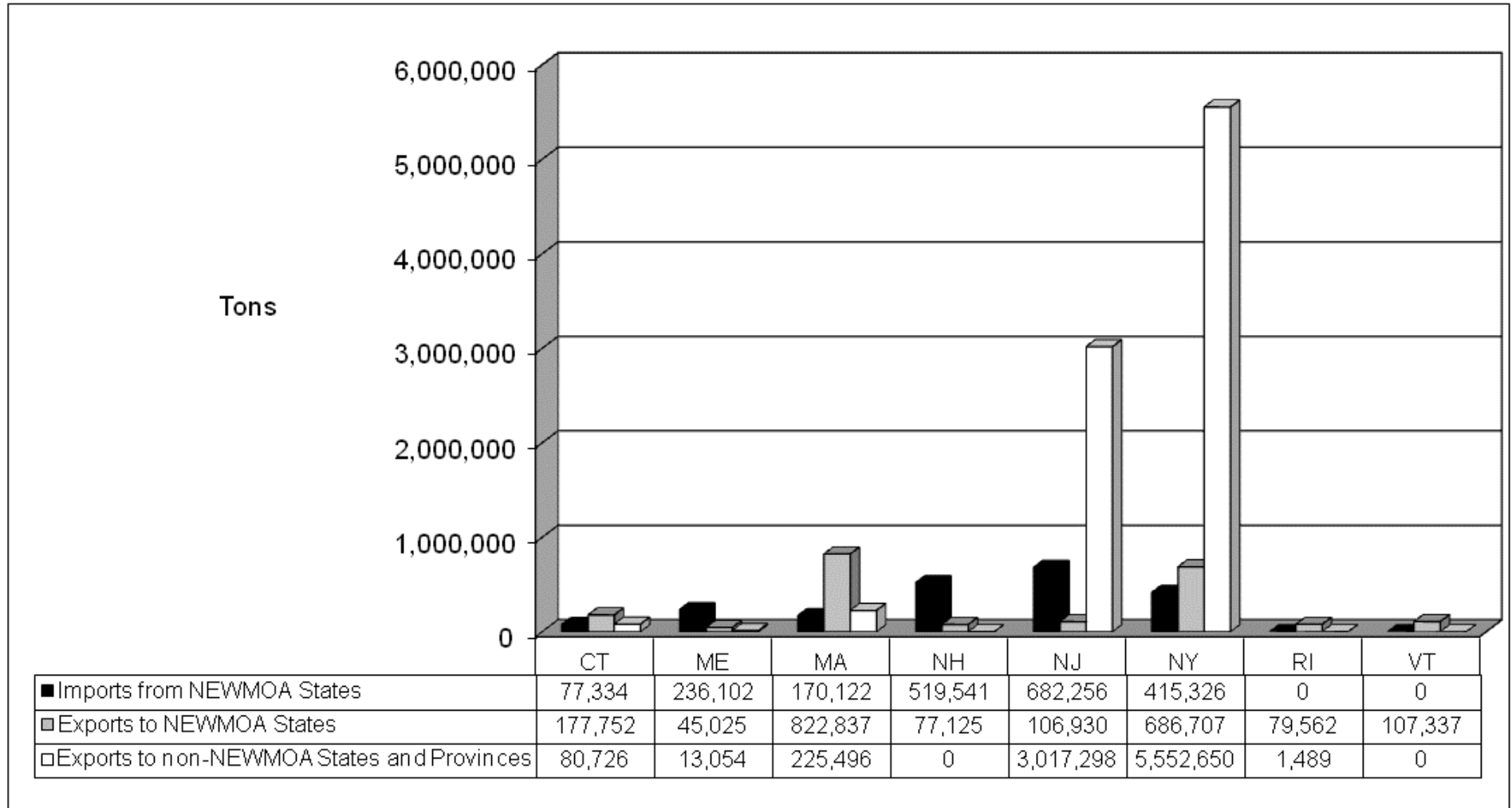

based on the data from the disposal facilities, since the Workgroup considers this data to be more accurate. As a result, the information presented in the figures might vary from data published by individual states for two primary reasons:

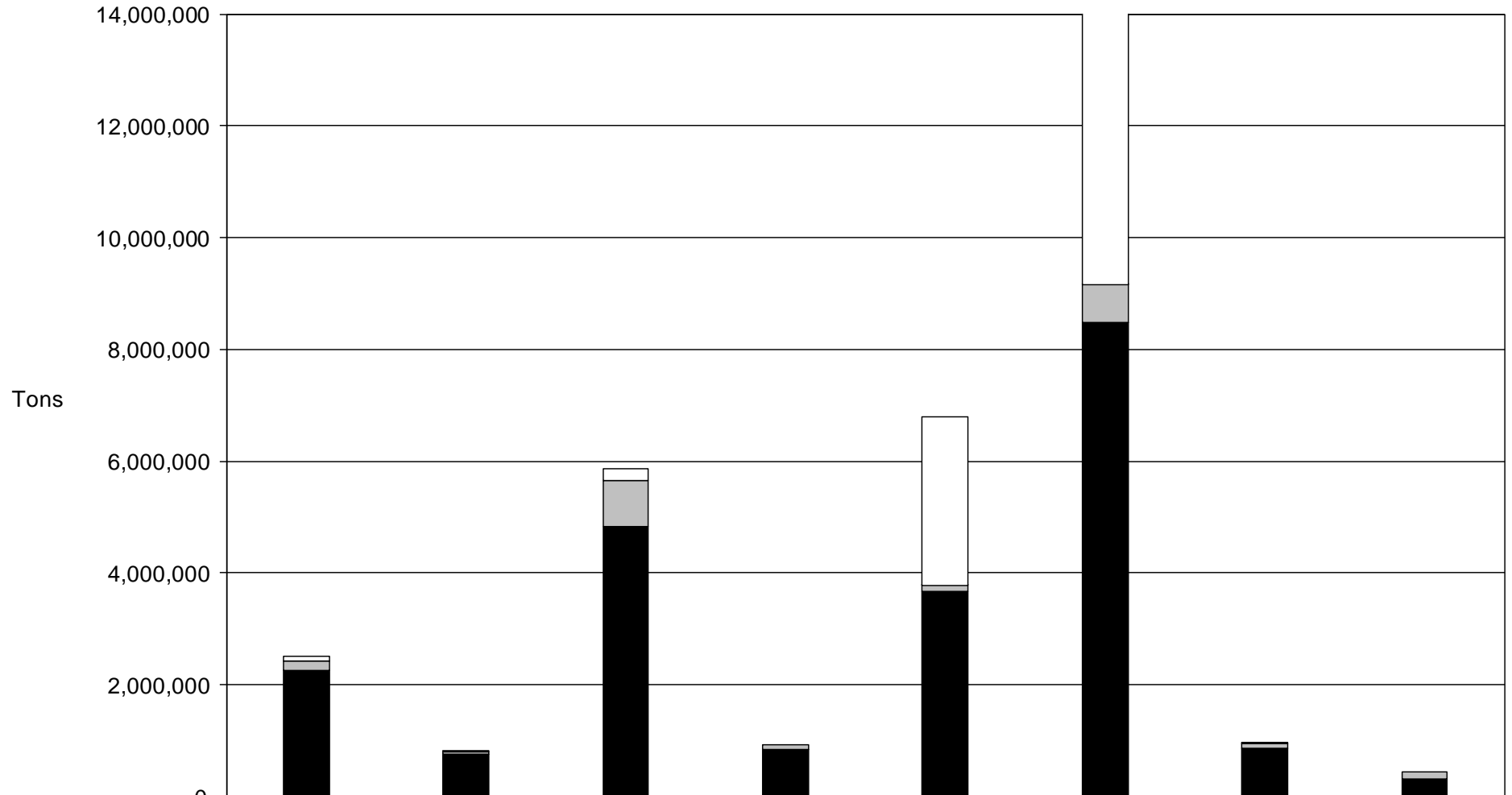
- If MSW is hauled directly from the pick-up route to an out-of-state disposal facility or transfer station, the MSW does not pass through a regulated facility in the state of origin and, therefore, is not provided by the state in which it was generated (called the generating state)
- If waste is transported to an out-of-state transfer station, and then sent from there to a disposal facility in a third state; the disposal facility would record the MSW as imported from the second state rather than the generating state – the second state is referred to as “pass through” in the notes on some of the figures below

By examining the MSW data provided by all of the NEWMOA-member states, the Workgroup adjusts for these situations and develops figures based on refined data. Because this presentation focuses on the NEWMOA region waste imports from and exports to non-NEWMOA-member states and/or Canadian provinces are aggregated into the “non-NEWMOA” or “Other” category.

Figure 3: 2008 Total Quantity of MSW Disposed of In-State (tons)

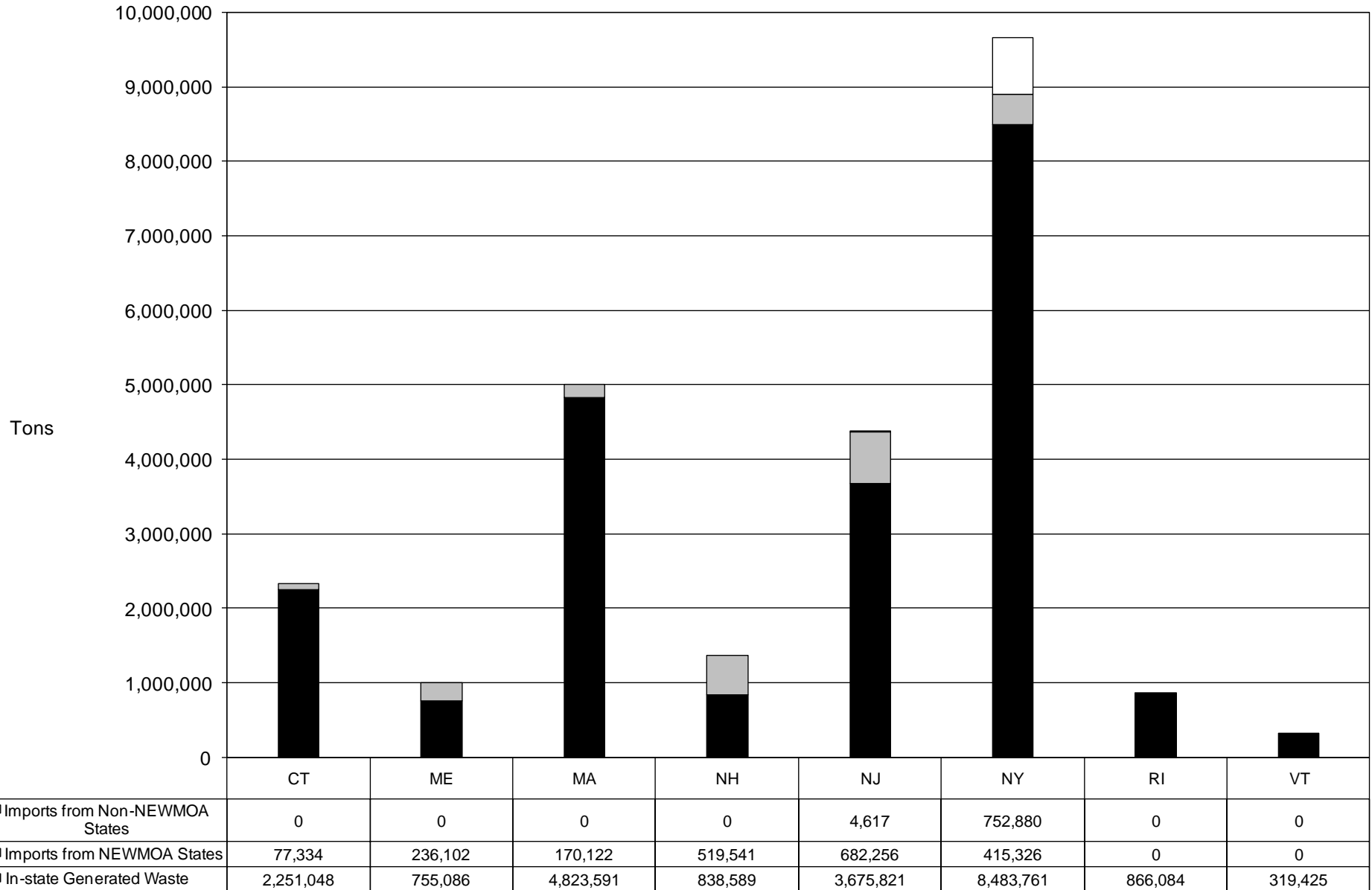
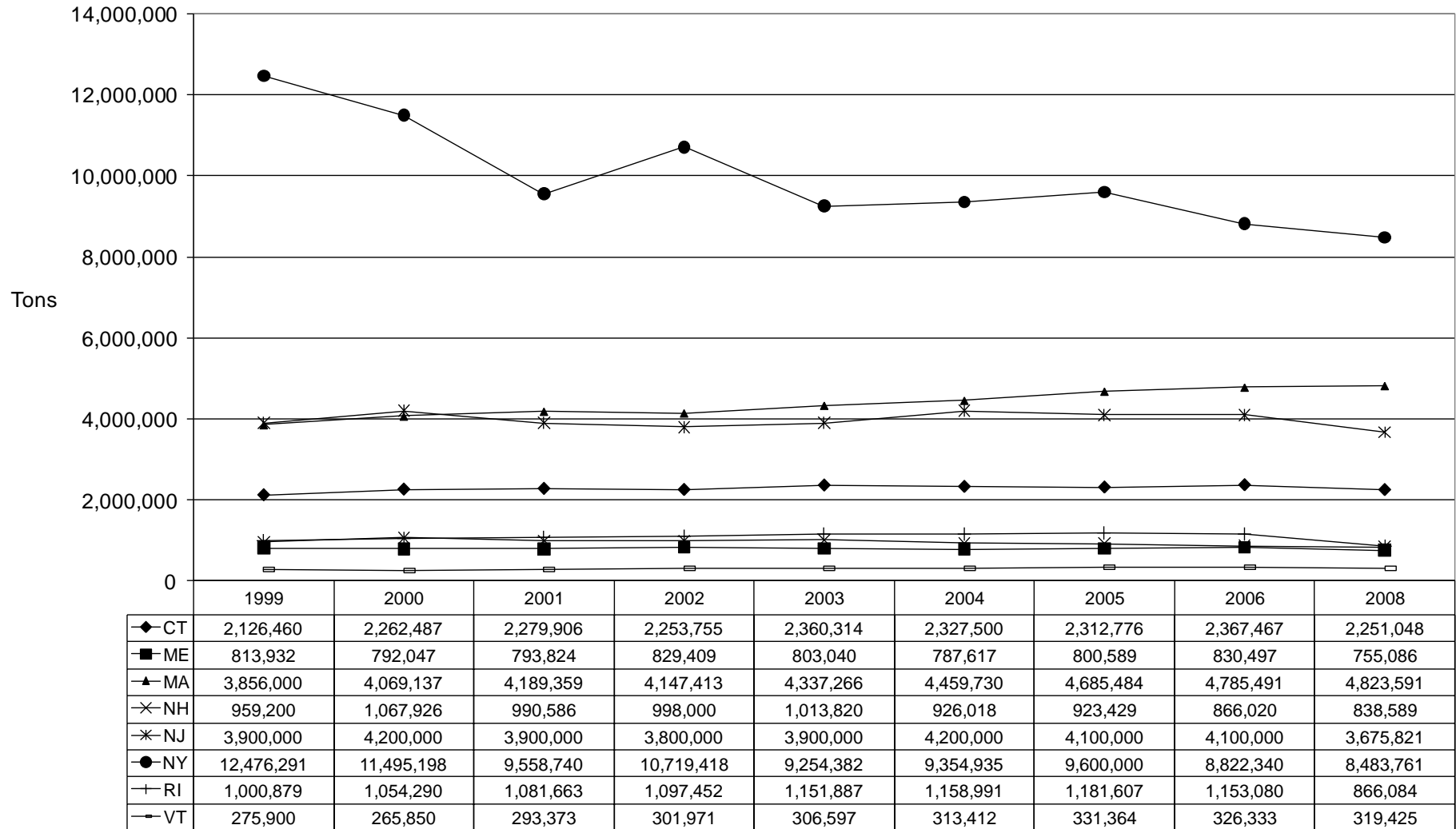
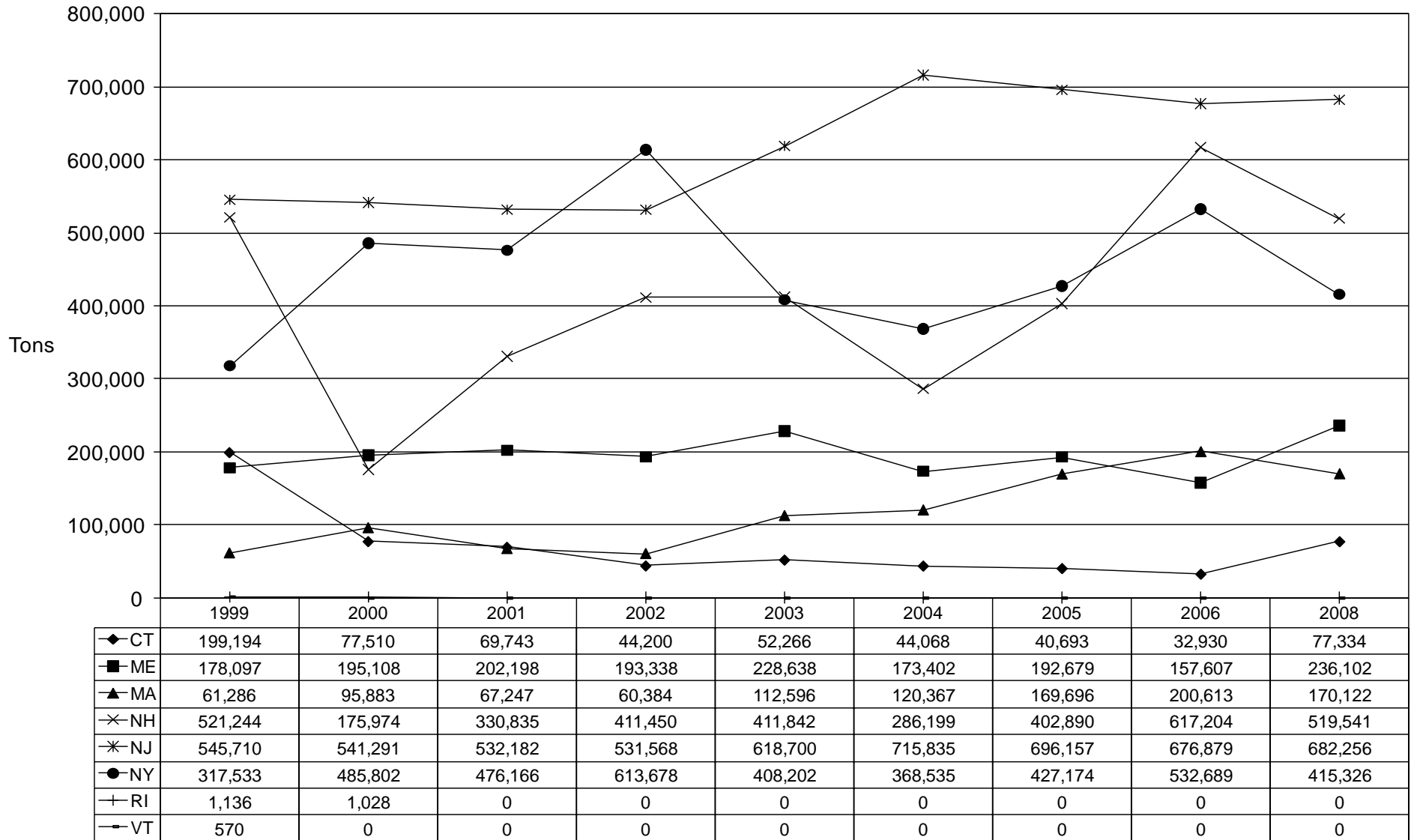


Figure 4: In-State Disposal of MSW Generated In-State: 1999 through 2008 (tons)

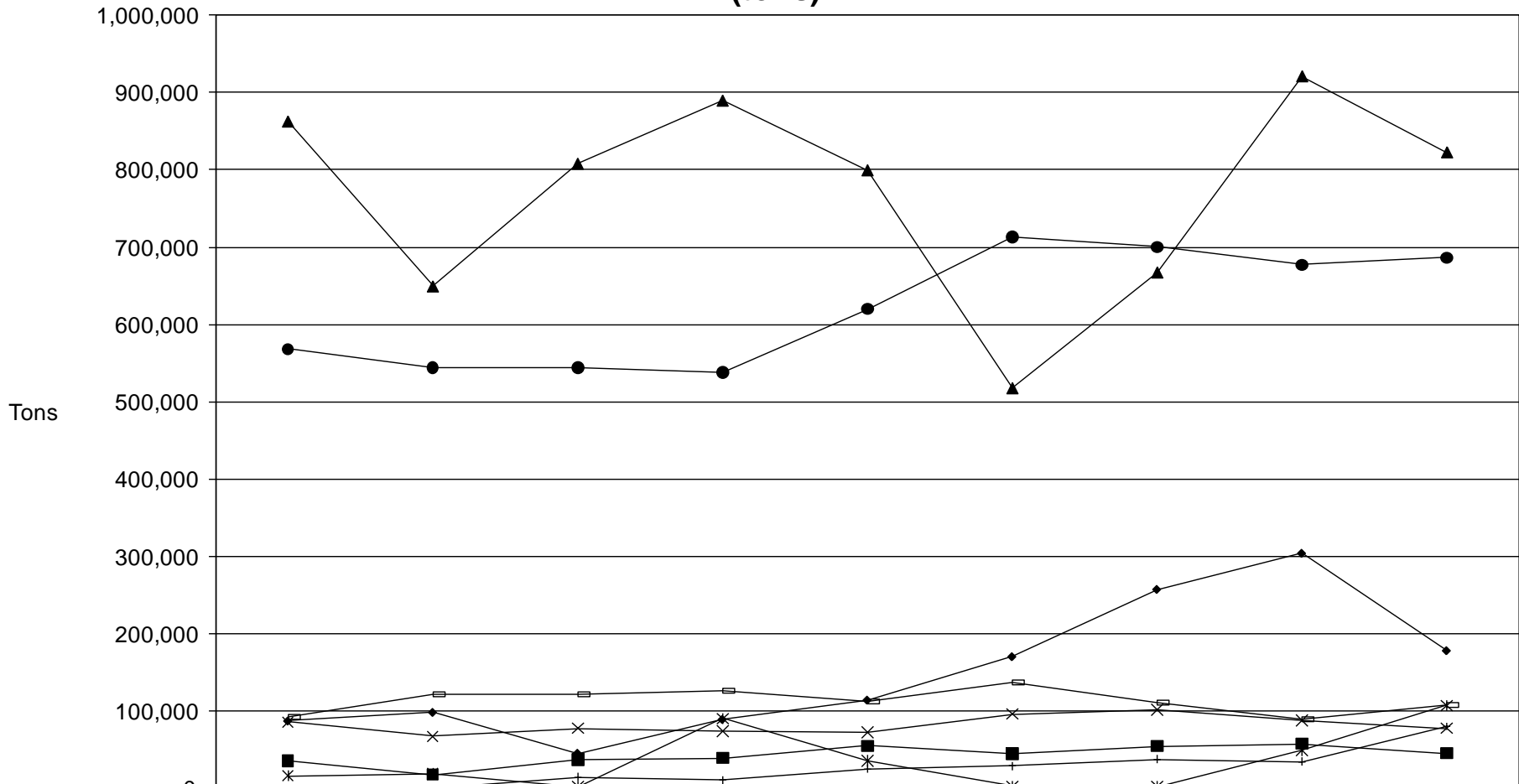

(tons)**

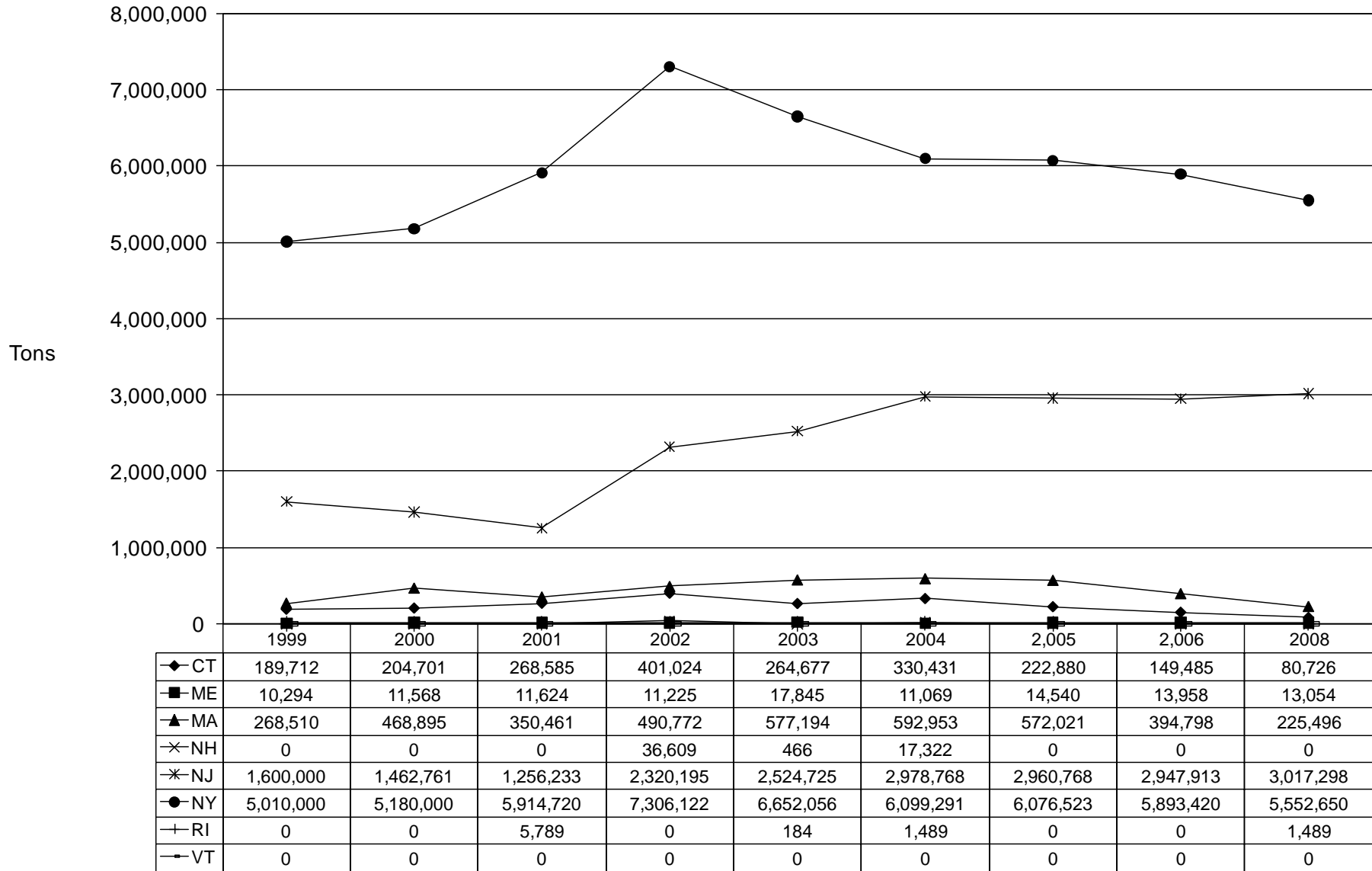


**Figure 6: MSW Exports to NEWMOA States: 1999 through 2008
(tons)**

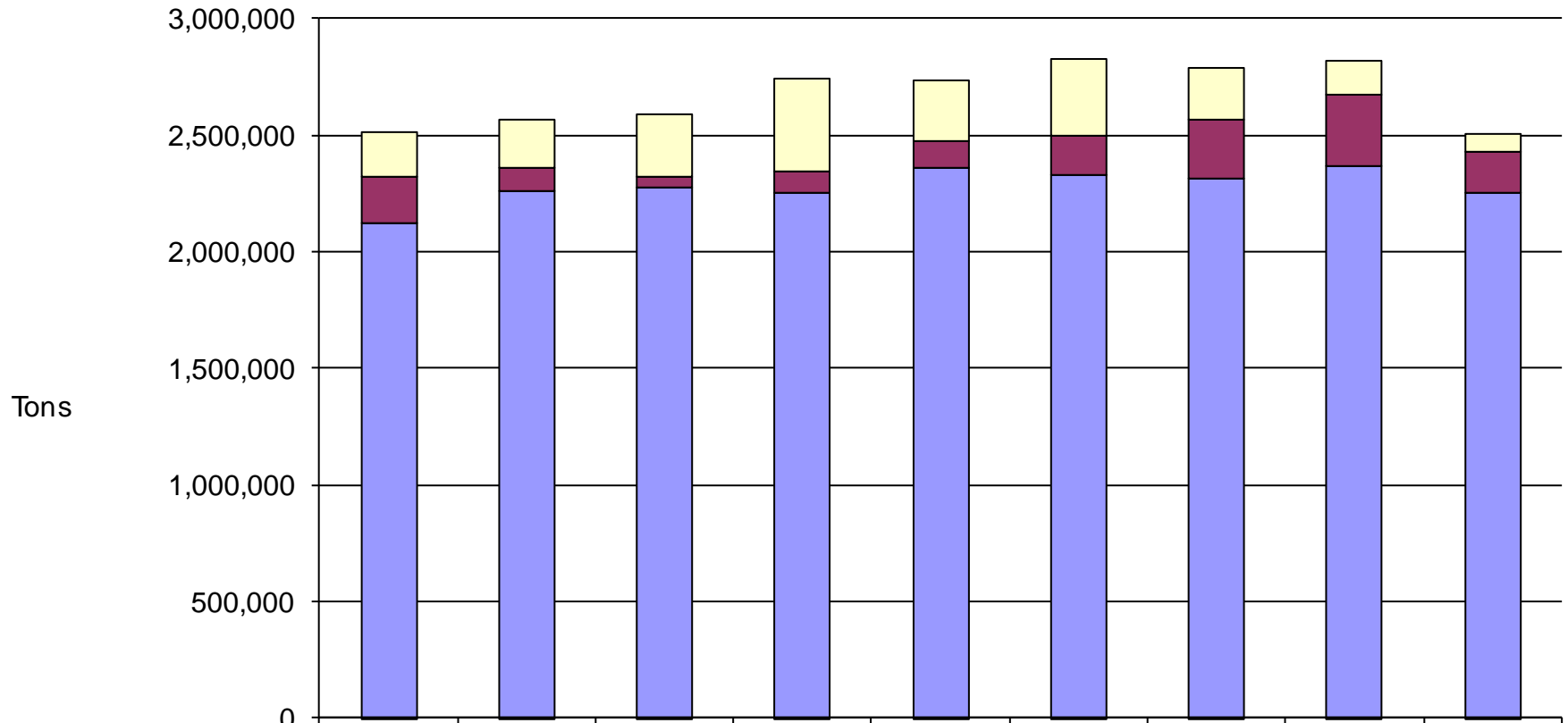

1999 through 2008 (tons)**

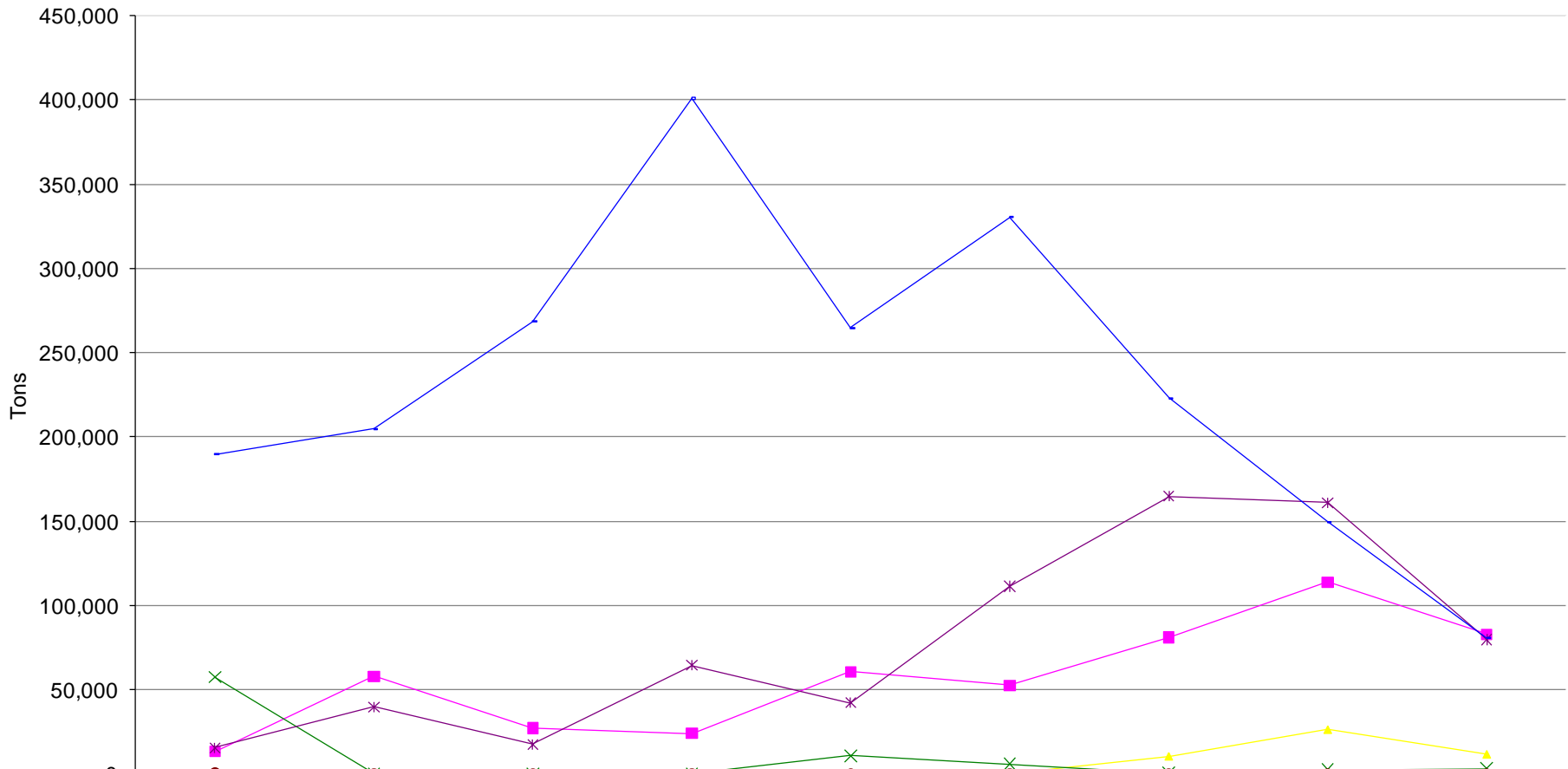


**Figure 8: MSW Generated in Connecticut & Disposed: 1999 through 2008

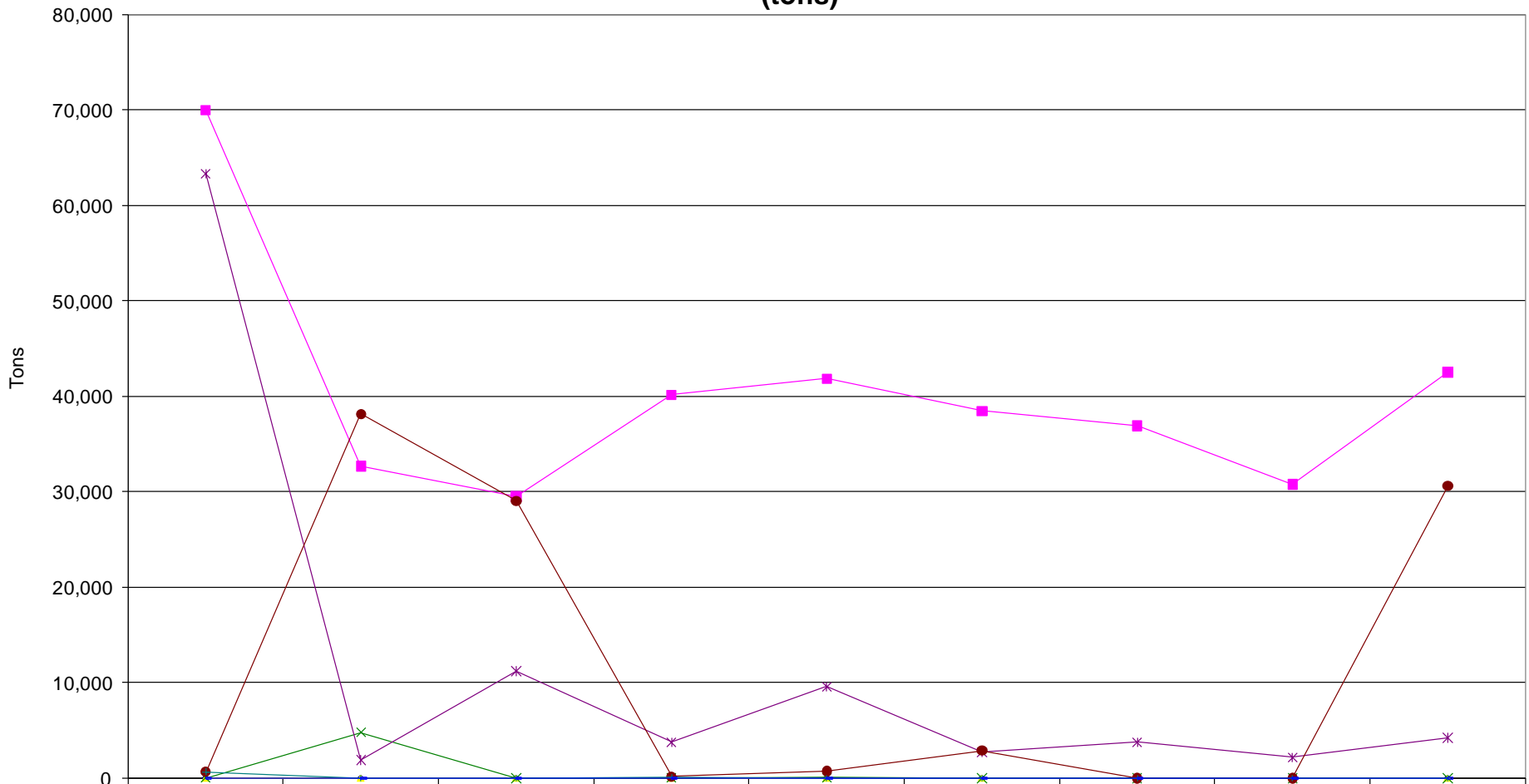

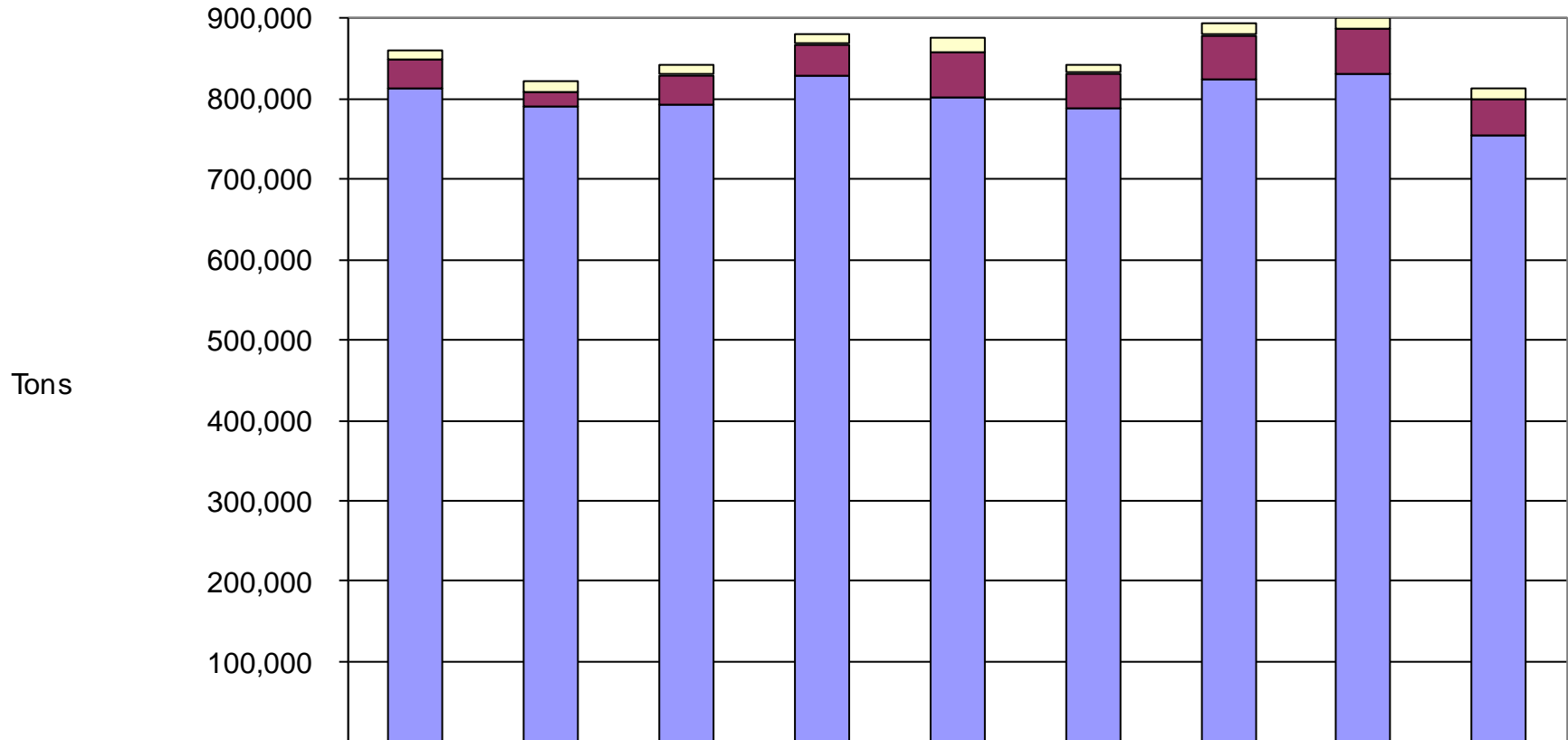

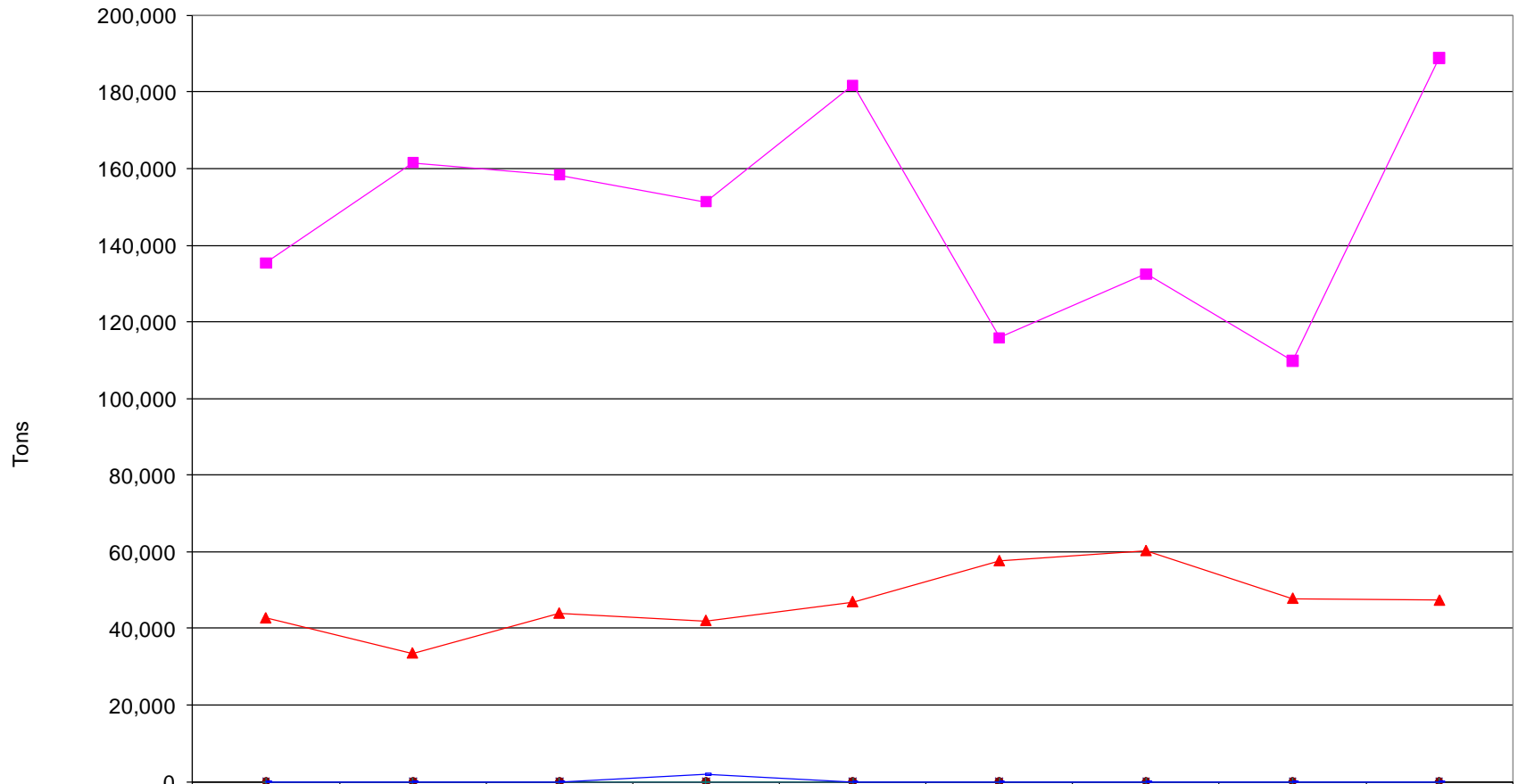

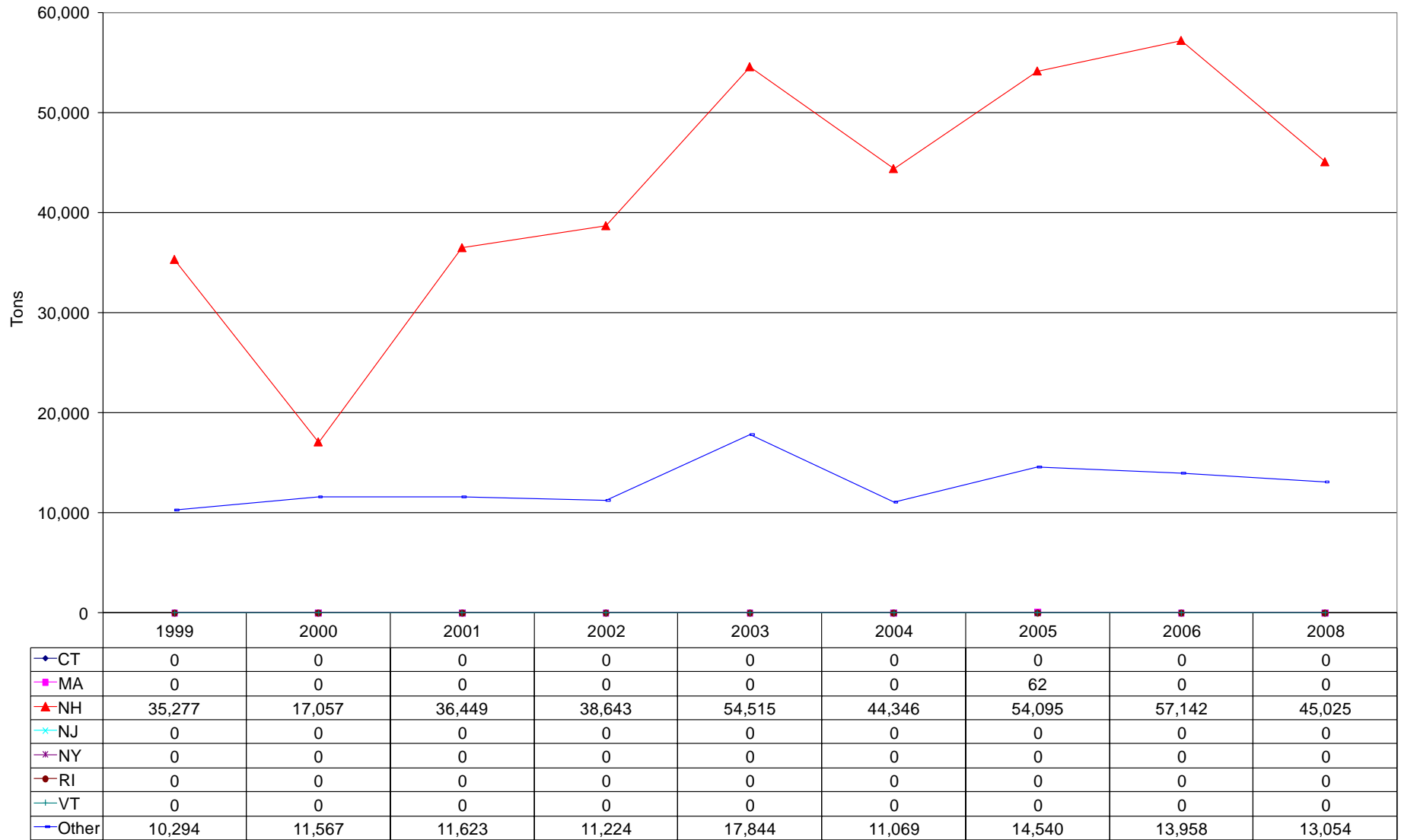

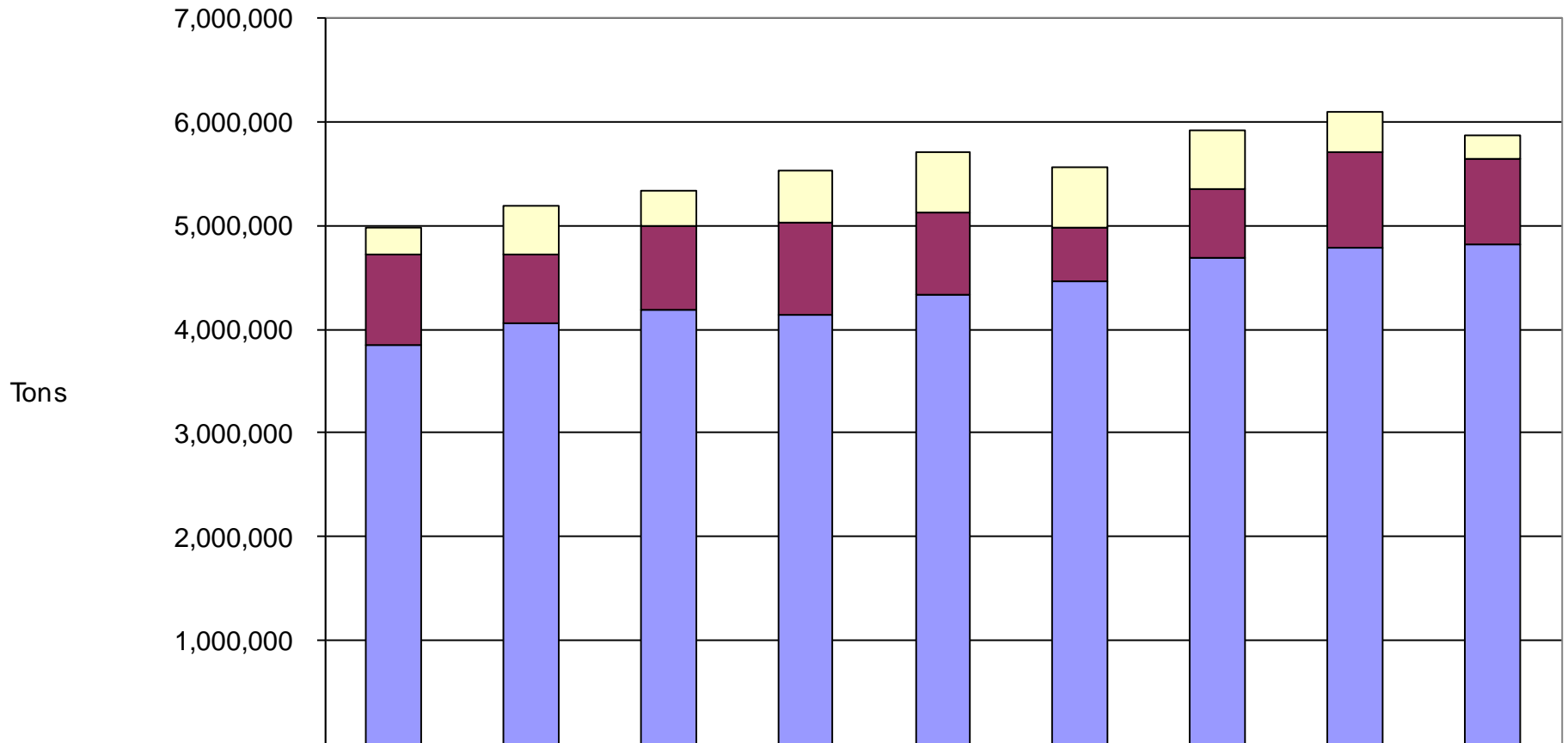

(tons)**

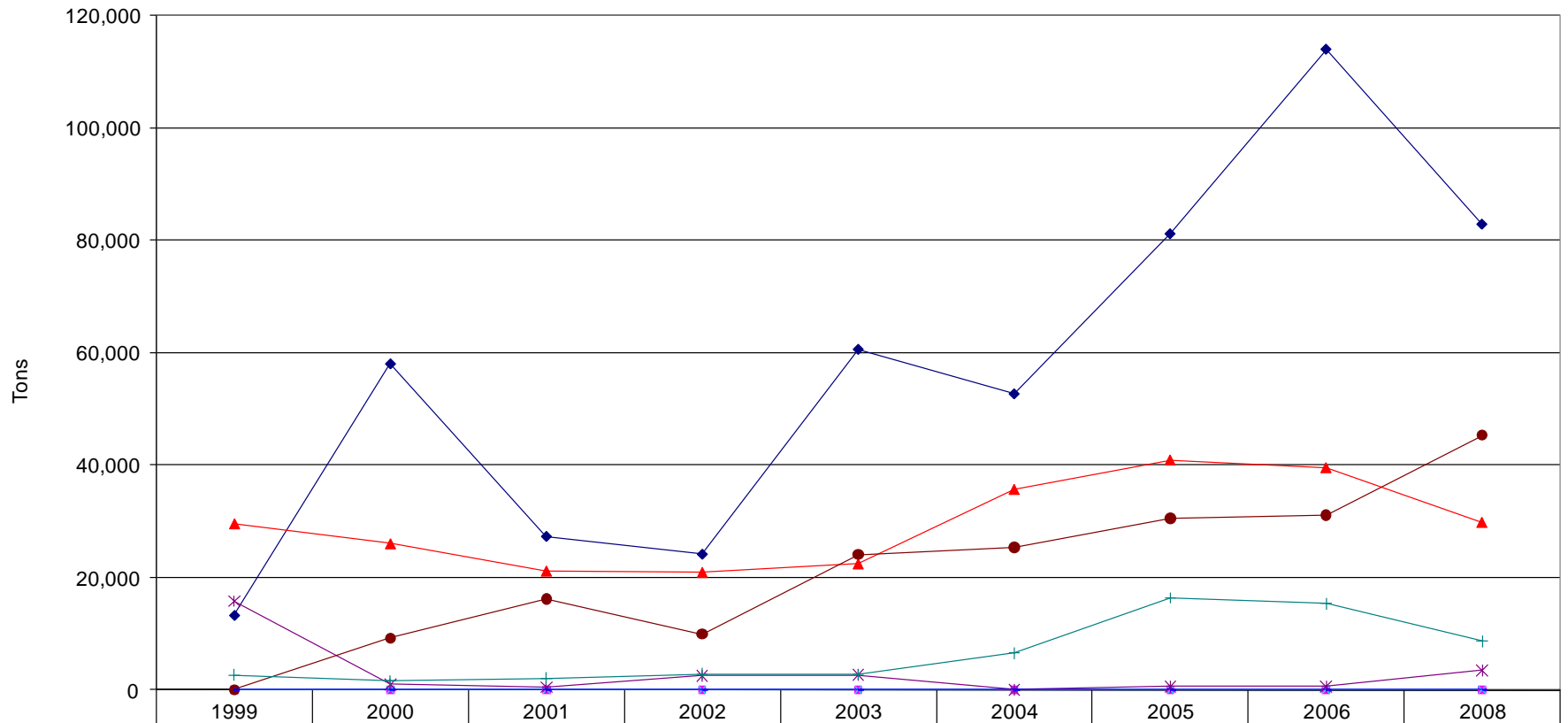


**Figure 14: MSW Generated in Massachusetts & Disposed: 1999 through 2008
(tons)**



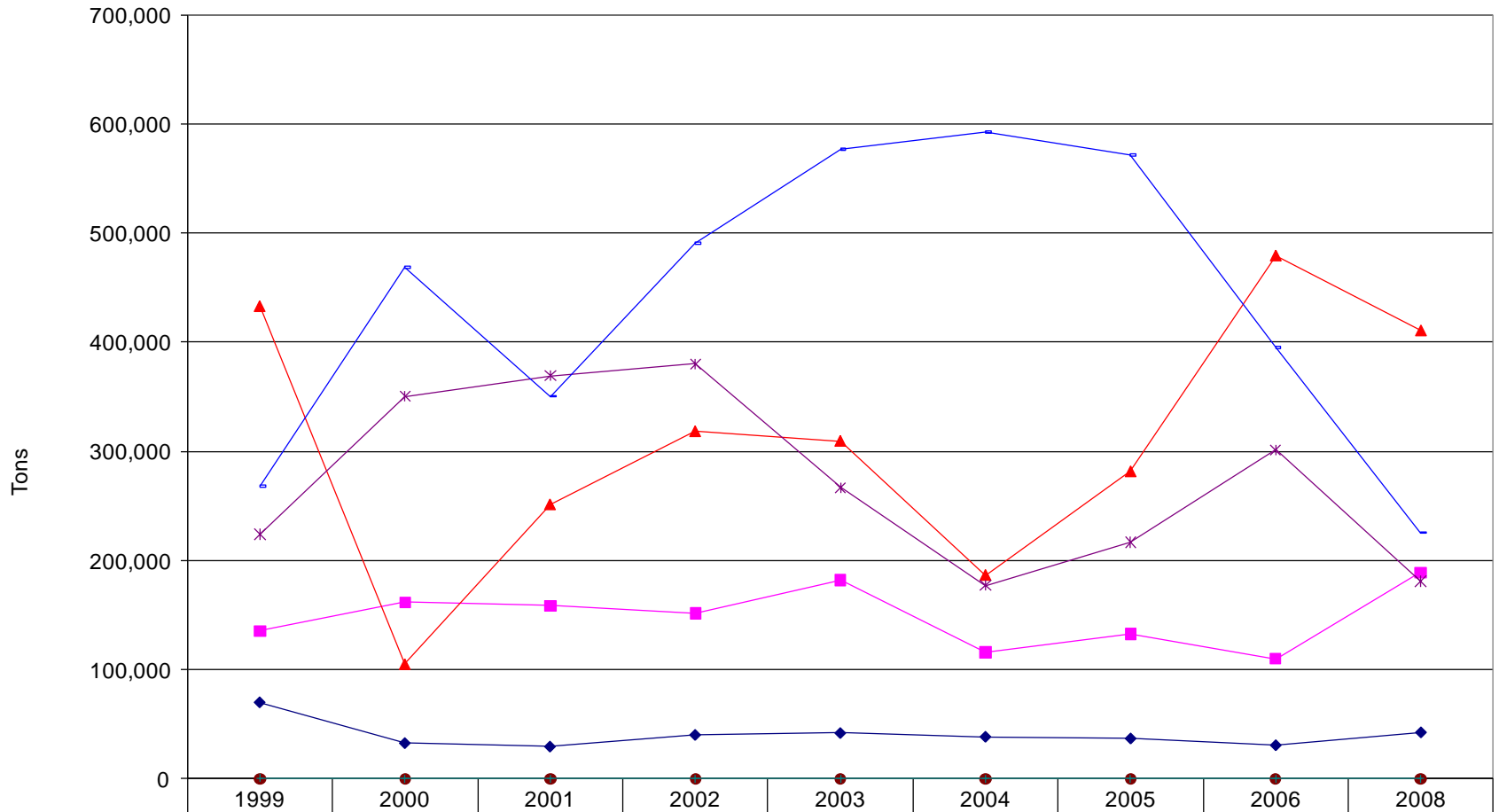

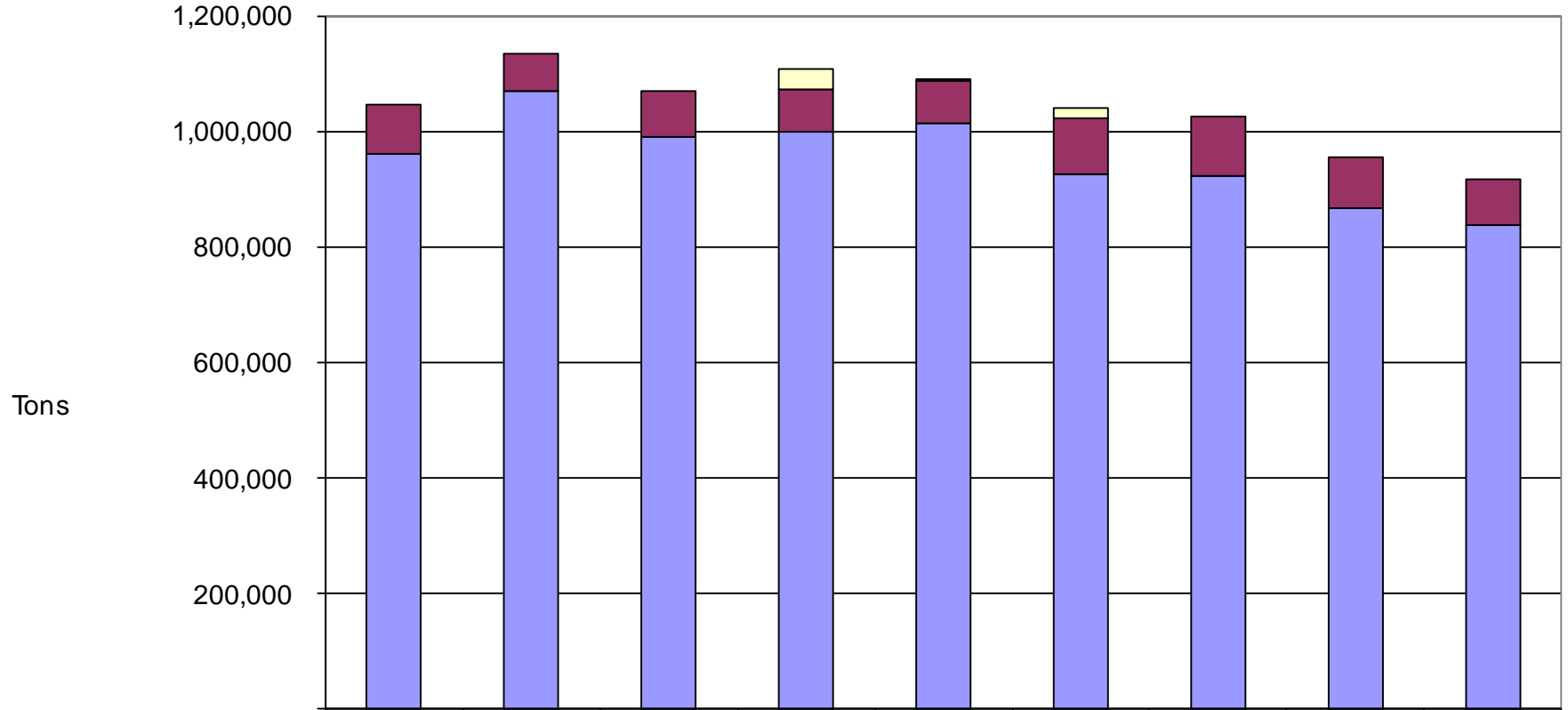

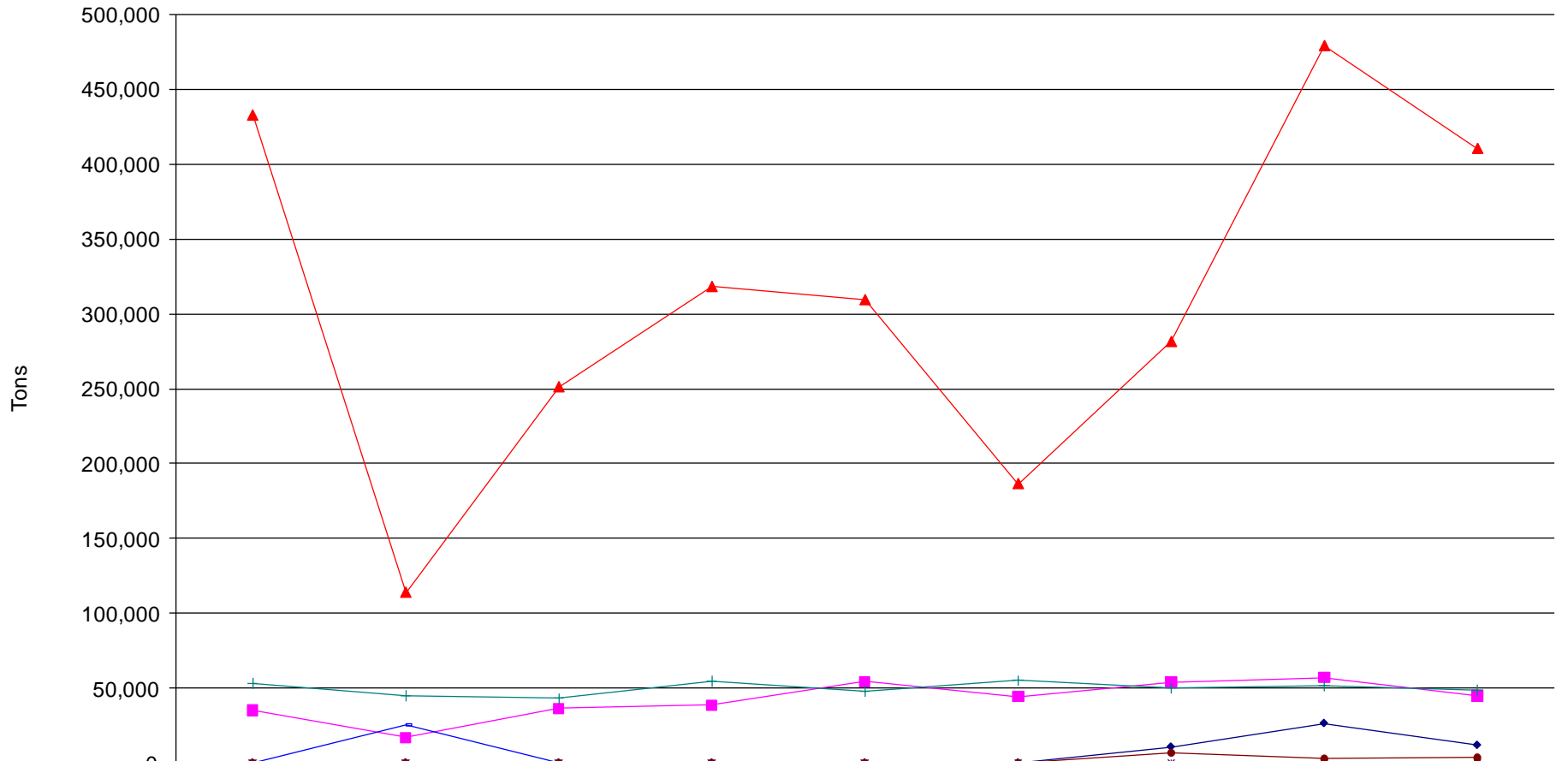

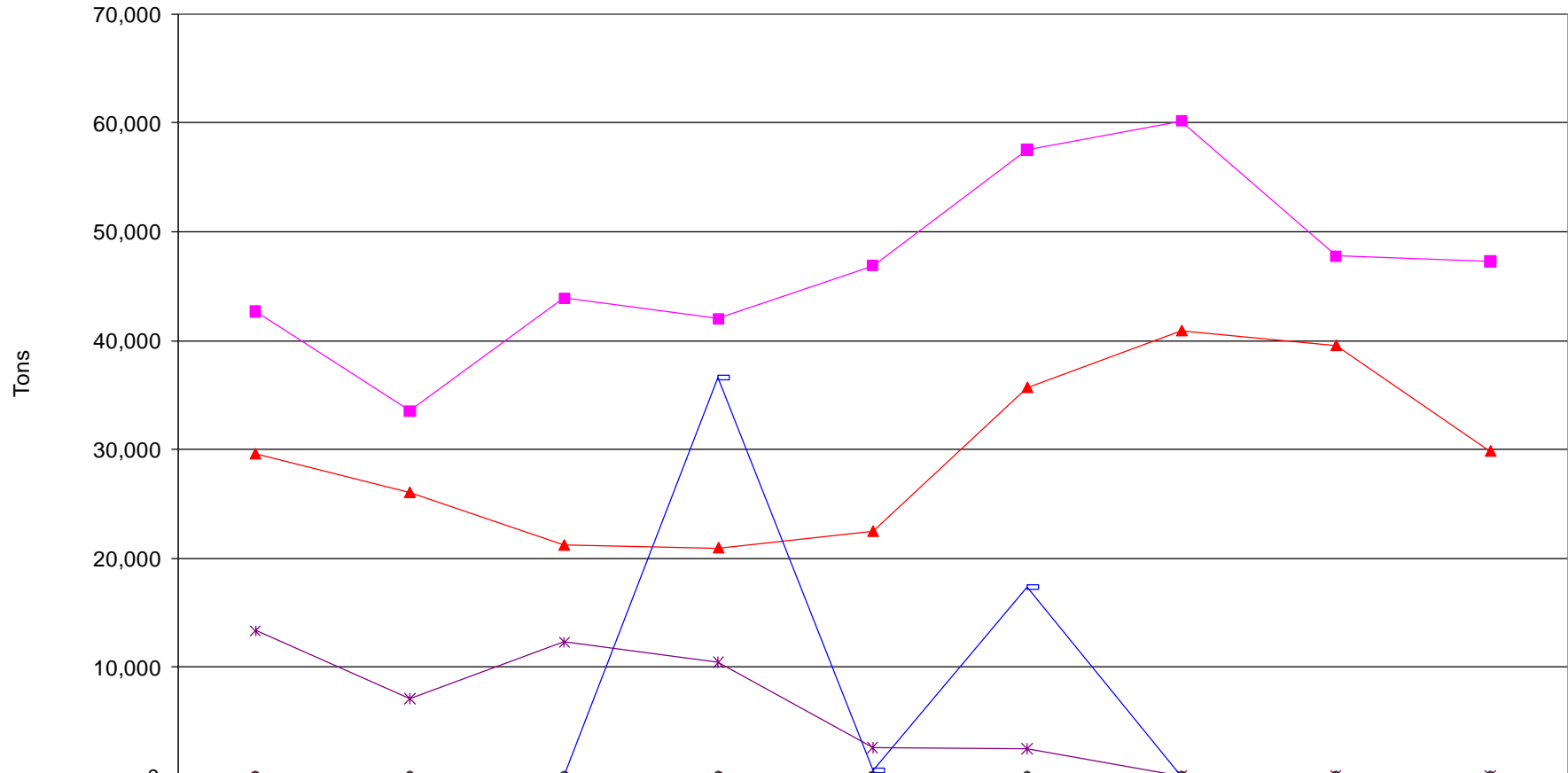

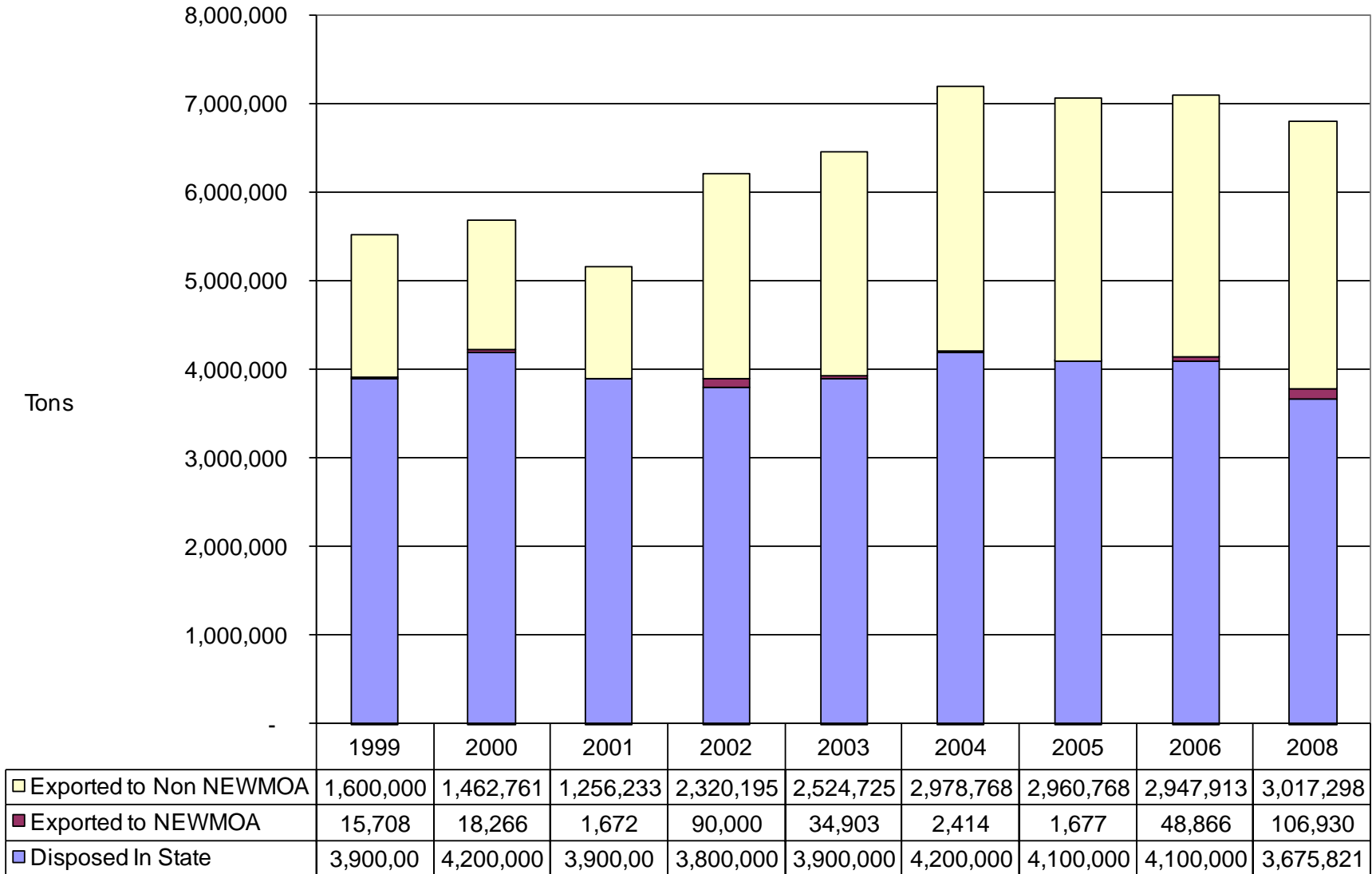

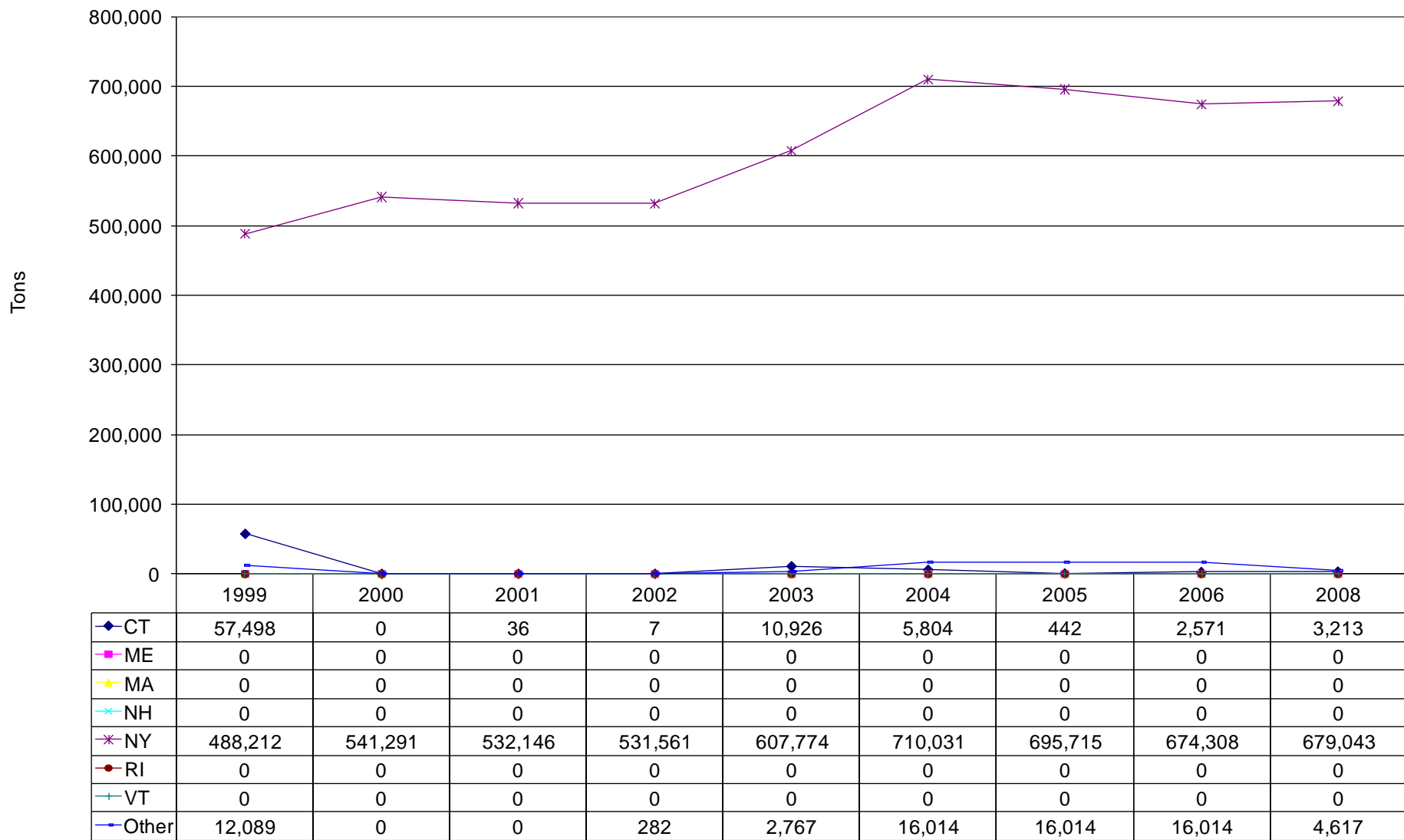

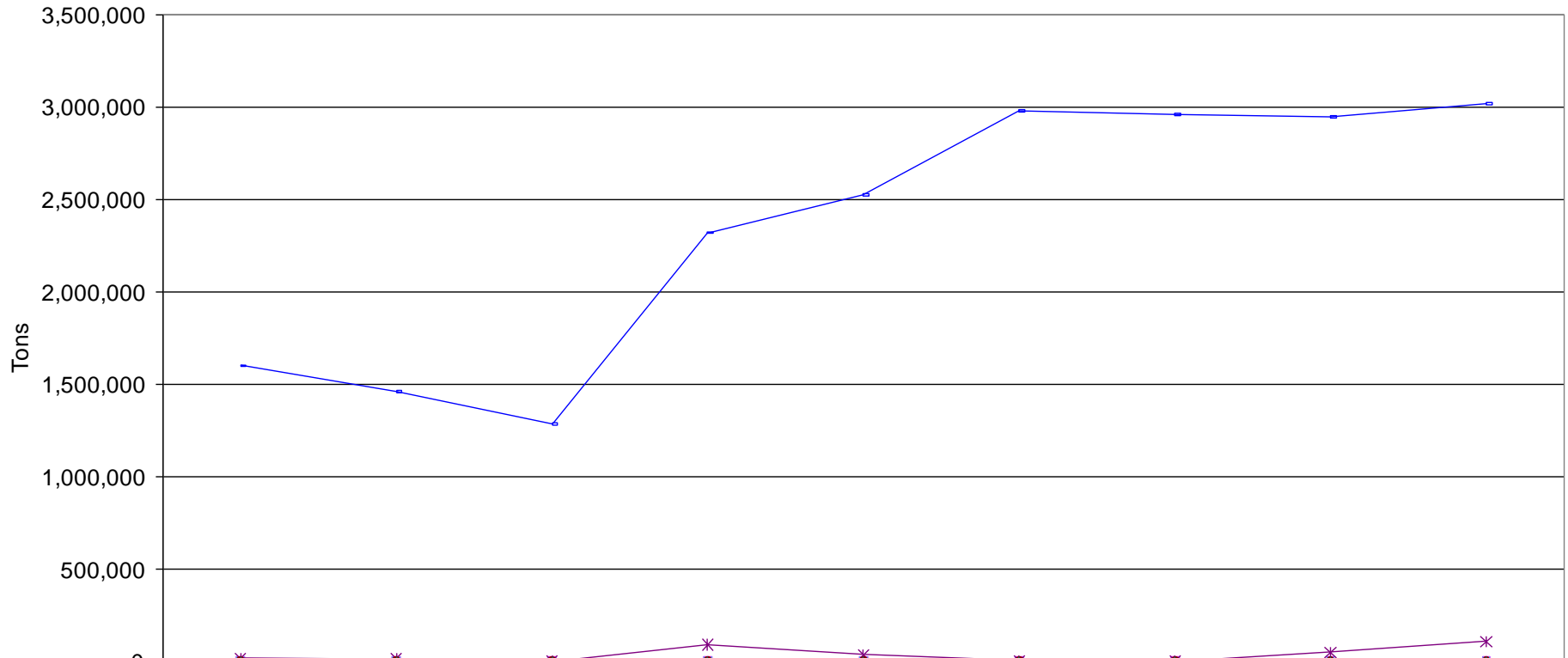


**Figure 21: MSW Imports to New Jersey: 1999 through 2008
(tons)**



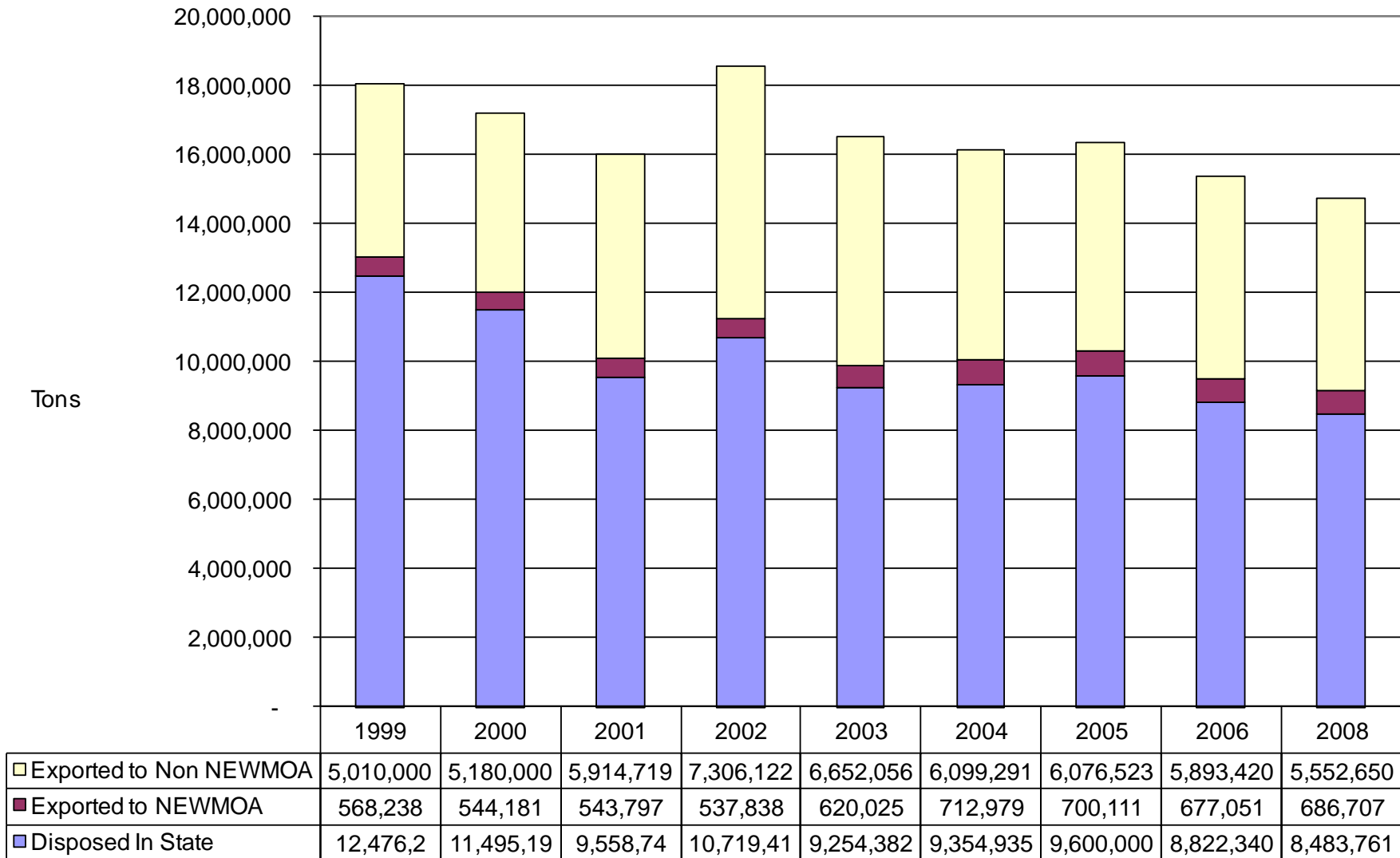

(tons)**



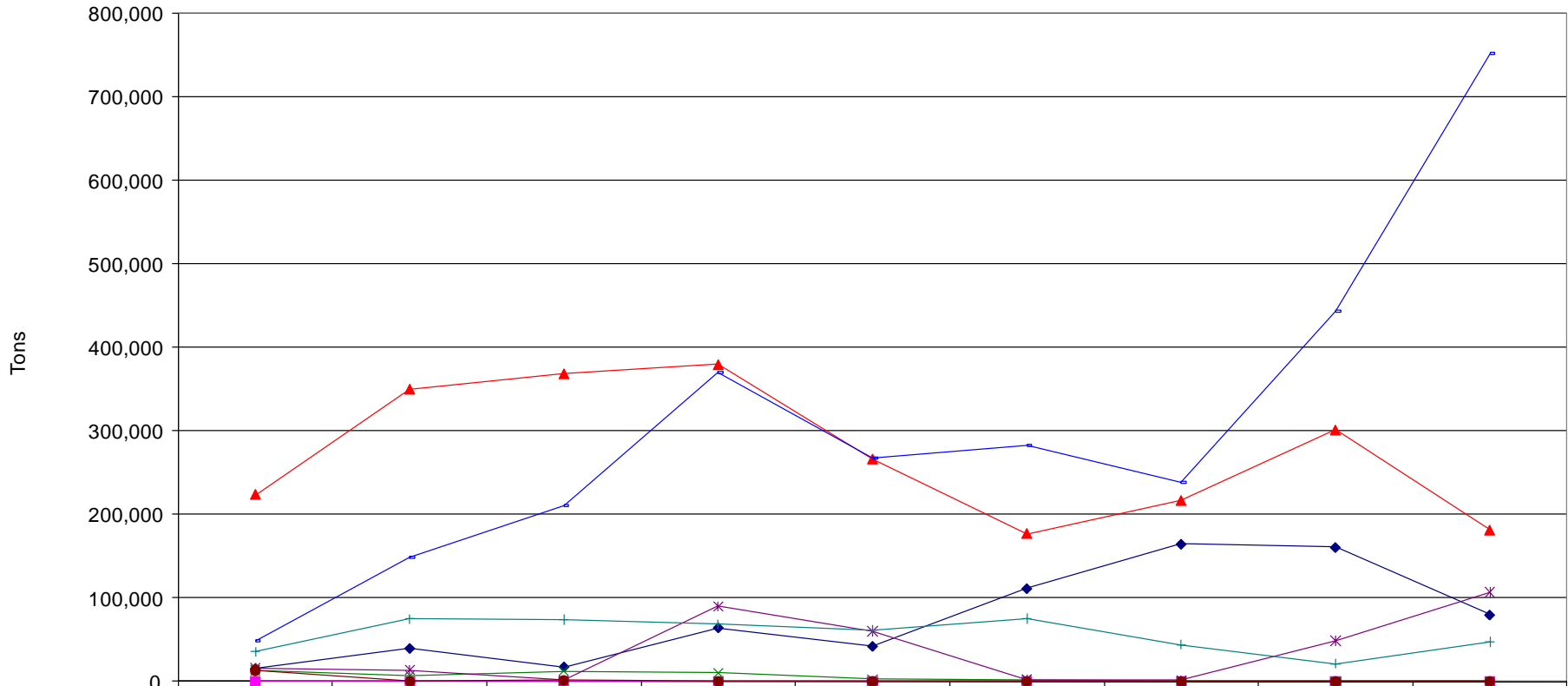

Figure 23: MSW Generated in New York & Disposed: 1999 through 2008 (tons)



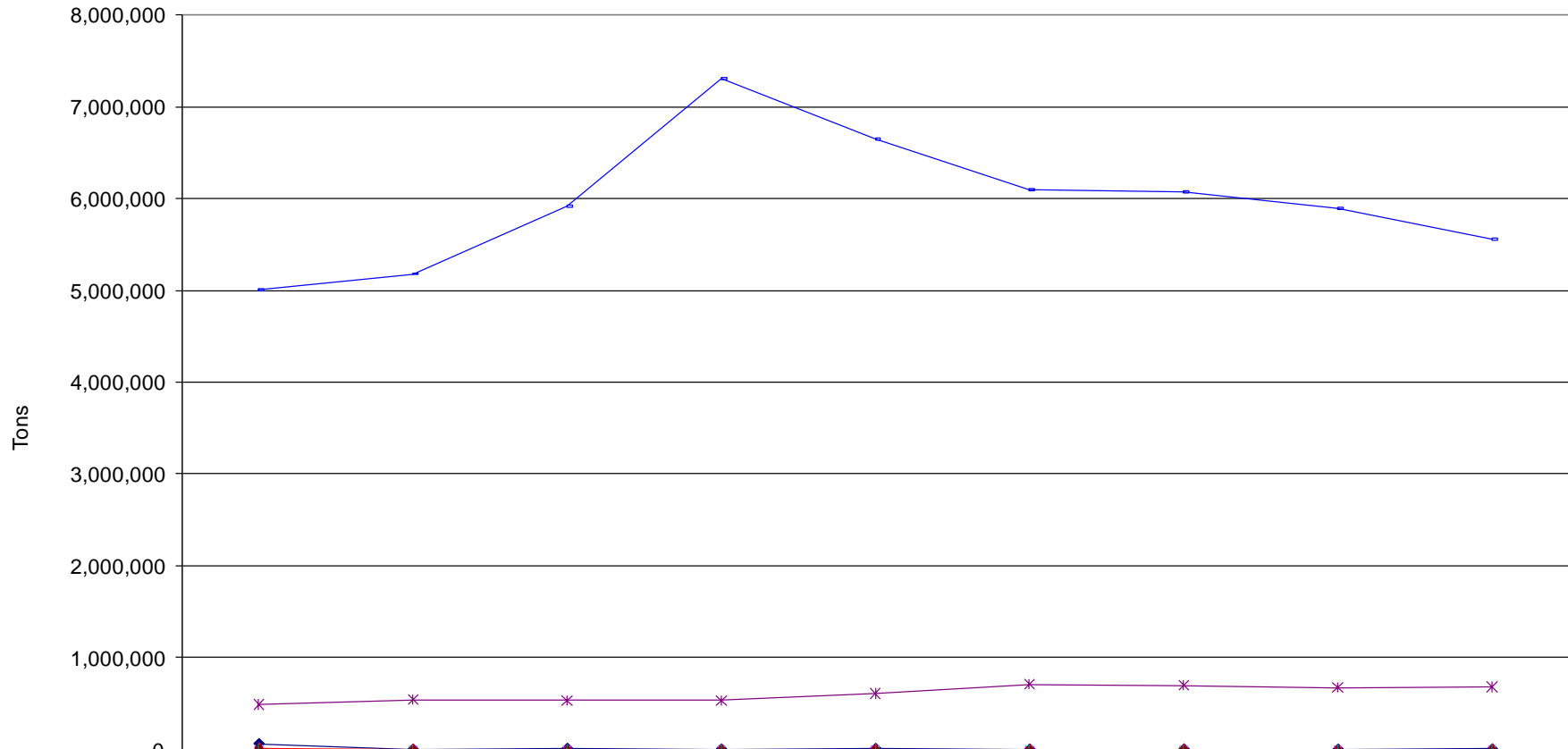

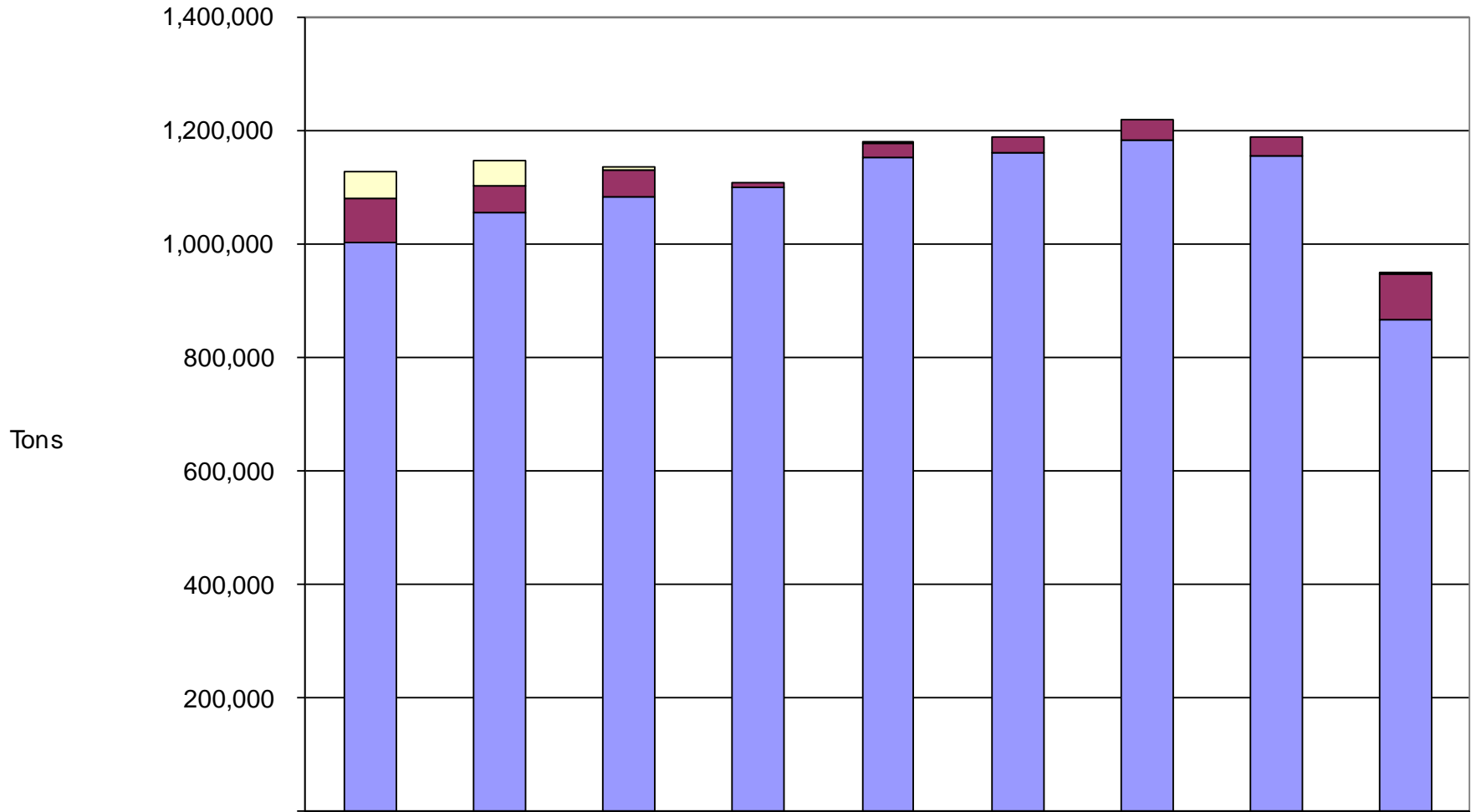
**Figure 25: MSW Exports from New York: 1999 through 2008

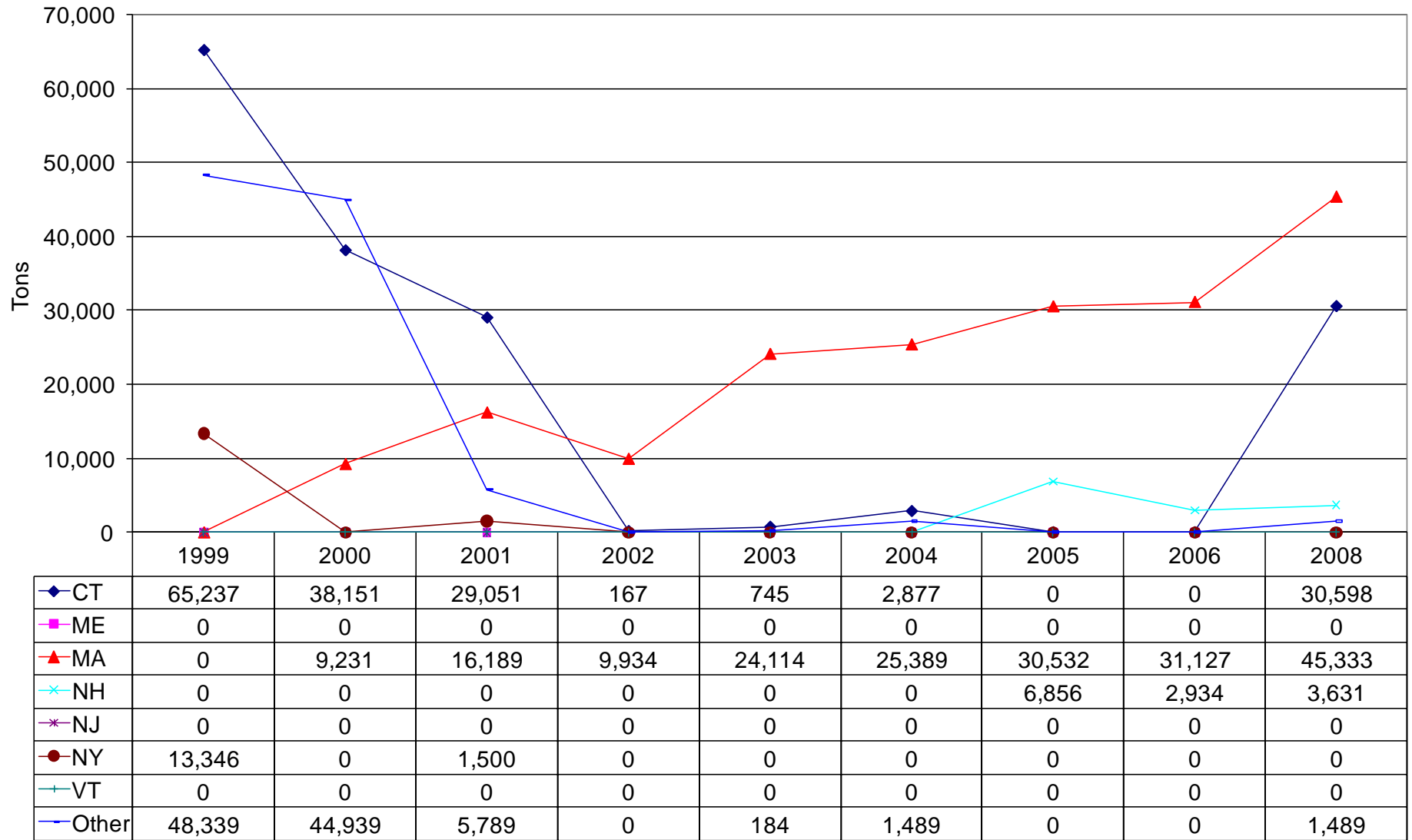

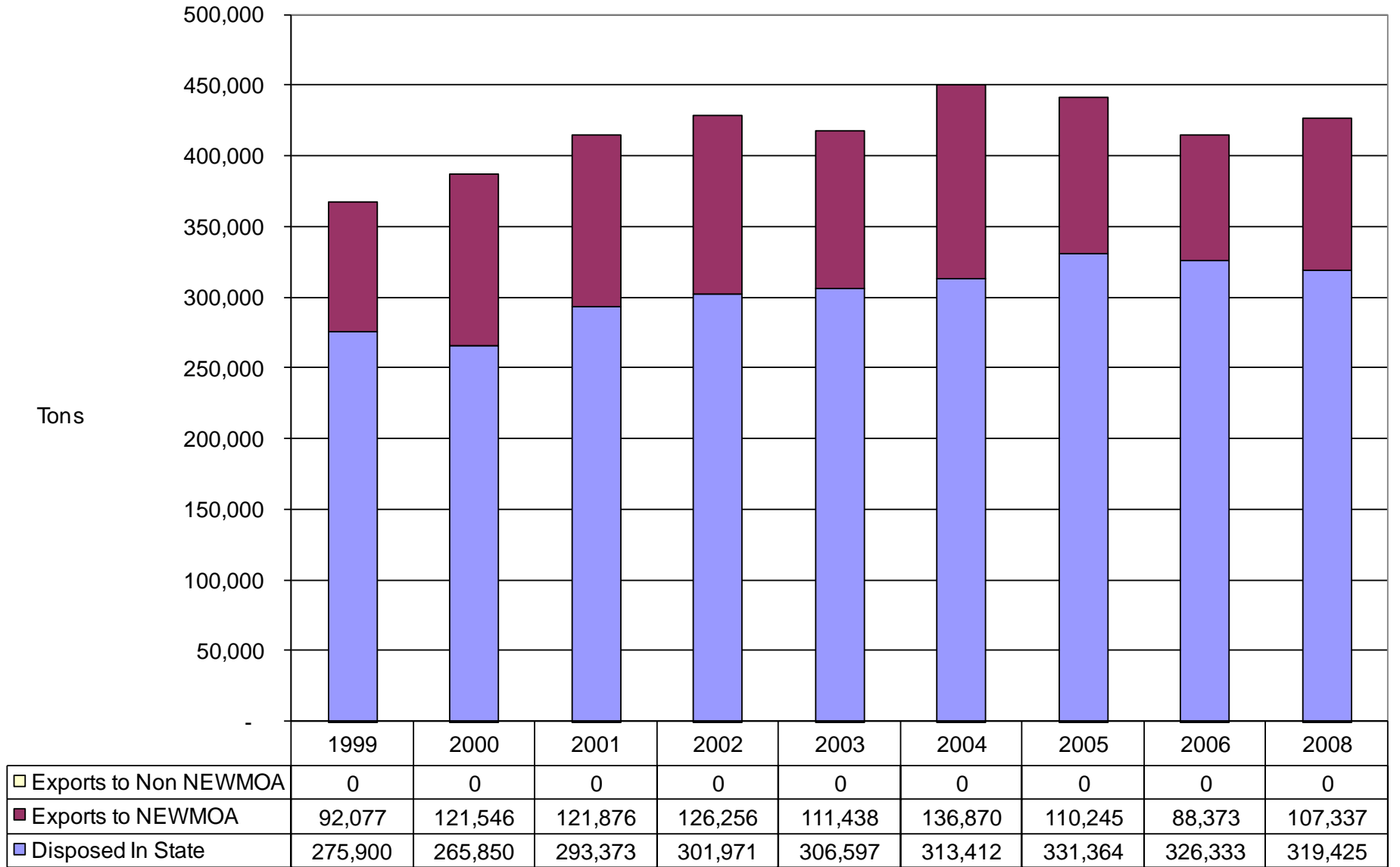
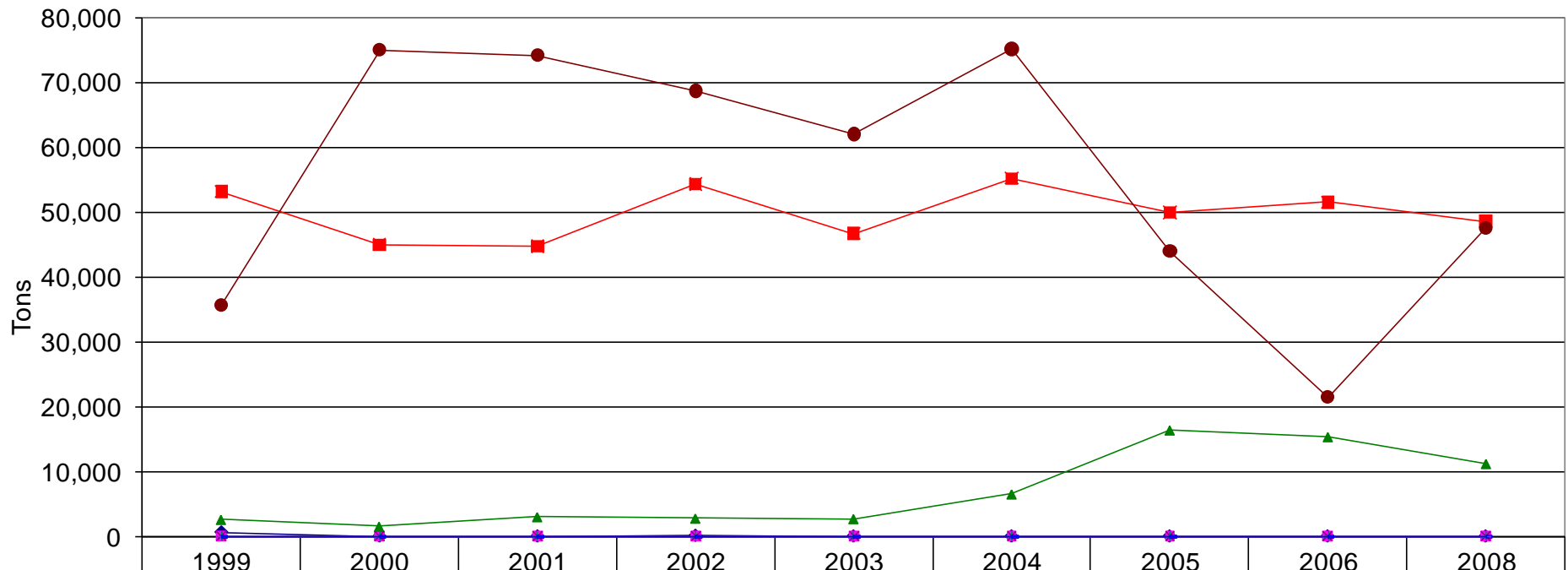


Figure 29: MSW Exports from Vermont: 1999 through 2008 (tons)
