

## E-filing System Launching in Early July 2011

As noted in the <u>January 2011 IMERC Alert</u>, the Interstate Mercury Education and Reduction Clearinghouse (IMERC) will be launching an online e-filing system for the reporting of mercury-added product information. The e-filing system replaces the paper Mercury-added Product Notification Forms used during prior reporting periods and will enable companies to comply with the Mercury-added Product Notification requirements of Connecticut, Louisiana, Maine, Massachusetts, New Hampshire, New York, Rhode Island, and Vermont. The IMERC e-filing system is scheduled to launch in early July 2011. After launch, companies will have until September 1<sup>st</sup> to complete their 2010 Triennial notification submission. IMERC will send an IMERC Alert approximately two weeks before the new system launches to notify all filers of the specific launch date.

## **Preparation for 2010 Triennial Reporting**

Prior to the launch of the new e-filing system, IMERC recommends that companies take the following steps to help make the transition to online reporting.

<u>Confirm company contact</u>. When the new e-filing system launches, the current company contact listed in the IMERC database will be asked to register for the system. If the current contact is no longer responsible for IMERC reporting, this may lead to delays in filing your 2010 Triennial submission. Due to privacy concerns, this information is not available online – you must contact IMERC directly.

<u>Review previous submission</u>. In order to reduce the data entry necessary to complete the 2010 Triennial submission, a company's online submission will pre-populate with the products last reported to IMERC. To review your company's last submission, visit the IMERC Mercury-added Products Database at:

locate your company's name. For most companies, the information listed in the "2007 Triennial Filing" will be the information that pre-populates your 2010 report.

If you note any inconsistencies in the data entered into the system, please contact Adam Wienert, IMERC Coordinator at <a href="mailto:awienert@newmoa.org">awienert@newmoa.org</a>. NOTE: The data listed in the database may not directly match with the information provided in your previous paper Notification Form. In some instances, IMERC staff has changed product names or grouped products together in order to retain consistency across the entire universe of products entered into the Mercury-added Products Database.

Begin collecting product data. IMERC encourages companies to begin collecting the data necessary to complete their 2010 Triennial submission. Because product information collected in the e-filing system will be the same as previous reporting periods, the paper IMERC Notification Forms can serve as a template to gather the necessary data and are available at: <a href="http://www.newmoa.org/prevention/mercury/imerc/notificationforms.cfm">http://www.newmoa.org/prevention/mercury/imerc/notificationforms.cfm</a>. ## **State Product Phase-outs and Bans**

Since the 2007 Triennial reporting period, a number of IMERC-member states have initiated bans or phased-out the sale of certain mercury-added products. If you have received an approved exemption to these bans from any state listed above, please note you must continue to provide notification information for those products, including replacement parts.
