

Vermont's Universal Recycling Law (Act 148)

- → Passed unanimously in 2012
- → Effectively bans:
 - Blue Bin recyclables (2015)
 - Leaf and yard debris, clean wood (2016)
 - Food scraps (2014-2020)
- → The goal: Improve capture and diversion rates to prevent valuable materials from being landfilled




Source Separation - It's the Law

Sec. 1. 10 V.S.A§ 6602. DEFINITIONS

- (31) "Food residual" means source separated and uncontaminated material that is derived from processing or discarding of food and that is recyclable, in a manner consistent with section 6605k of this title. Food residual may include pre consumer and post-consumer food scraps. "Food residual" does not mean meat and meat-related products when the food residuals are composted by a resident on site.
- (32) "Source separated" or "source separation" means the **separation of compostable** and recyclable **materials from non -compostable** , non-recyclable materials **at the point of generation**.

Why Does Source Separation Matter?

- → Pathways for contamination
 - Micro- & nano-plastics
 - **◆**PFAS
 - Heavy Metals
 - Other toxins/pollutants
- → Soil & resource stewardship
 - Principle of Return
 - Precautionary Principle
- →Builds a culture of ecological literacy





Challenges in Implementatic


- → Diverse settings
- Confusion:
 - Different rules with different haulers, different compost facilities
 - Compostable packaging
- → Inconsistent messaging
- → "SSO isn't practical"
 - Social innovation vs. mechanical innovation

SSO Requires Behavior Change Among Generators

- → It starts with intention to change
 - Belief that it can be done solutionbased approach
- Behavior change is rarely motivated by information alone
- → Relational, collaborative
 - Composters-Haulers; Haulers-Generators
- Messaging: Explicit, clear, diversely redundant, inviting & fun

Getting it done on the ground

- → Set expectations
 - SSO as explicit base in contracts
 - Training: redundant messaging in multiple forms; iterative; beyond information transfer
 - Signage, labeling
- → Behavior modeling within existing culture
 - ◆ ID champions with strong social capital
- → Effective systems
 - Easy to use sorting areas
- → Load monitoring, picking and documenting
 - Real-time communication
 - Social media
 - Ability to refuse totes, loads

At the compost facility:

- → Picking piles, prescreening
- → Post-process removal
- ...Depack? It's a tool, not "THE" solution



New Legislation

H.501 an act relating the regulation of depackaging facilitie

(modified & folded into H446 act relating to misc. natural resources & development su

- → Moratorium on new depackaging facility certifications in Vermont
- Convene stakeholders to make recommendations
 - Organics Diversion Hierarchy, Source Separation, Proper use of depackagers
- → Study Microplastics & PFAS in food waste
- → Adopt rules for depackaging facility operation in Vermont

Opportunities to Reduce Contamination

Food Scrap Generators

- → Reduce waste; Reduce opportunities for contamination
- →PLU removal
- → Improved new hire/new student training
- →Internal workplace culture

Haulers

→ Develop some commonalities around SSO

Districts/State

- → Promote, support & enforce SSO: set an ambitious vision
- → More educational/training support
- → Product standards
- → Be intentional with depack messaging
- → See stewardship capacity as social capital – invest in it
