

2005 Municipal Solid Waste (MSW) Interstate Flow and Disposal in the Northeast States

Disclaimer

The tables and graphs contained in this report contain information based on data that was supplied by the NEWMOA member states. NEWMOA examines the data provided by states to identify and reconcile differences and, in consultation with the NEWMOA states determines the data to use in the graphs. NEWMOA also contacts the states that receive the majority of municipal solid waste (MSW) that leaves the NEWMOA region: Ohio, Pennsylvania, South Carolina and Virginia to obtain their data regarding imports to facilities in their states. Again, in consultation with the NEWMOA states NEWMOA determines the data to use regarding MSW sent to states outside the NEWMOA region. Generally, over time the quality of data obtained from the states has improved. There is more uncertainty associated with data from the earlier years included in this report; however, no data should be assumed to be 100 percent certain. The tables and graphs contained in this report were developed for use by the waste program directors in the NEWMOA states and the staff that participate in the project. Due to fiscal constraints, NEWMOA is unable to prepare and publish a full report suitable for public use.

About NEWMOA

The Northeast Waste Management Officials' Association (NEWMOA) is a nonprofit, nonpartisan, interstate association. The membership is composed of state environmental agency directors of the hazardous waste, solid waste, waste site cleanup, pollution prevention and underground storage tank programs in Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Rhode Island, and Vermont. NEWMOA was established by the governors of the New England states as an official interstate regional organization, in accordance with Section 1005 of the Resource Conservation and Recovery Act (RCRA) in 1986 and is funded by state membership dues and contracts and EPA grants.

NEWMOA's mission is to develop and sustain an effective partnership of states to explore, develop, promote, and implement environmentally sound solutions for the reduction and management of materials and waste, and for the remediation of contaminated sites, in order to achieve a clean and healthy environment. Figure 1: 2005 MSW Imports and Exports (tons)




Figure 2: MSW Generated by State and Disposed (2005, in tons)




Figure 3: Total Quantity of MSW Disposed of In-State (2005, in tons)




Figure 4: 2005 Exports to Non-NEWMOA States and Provinces



1999 through 2005**




Figure 6: MSW Imports from NEWMOA States: 1999 through 2005 (tons)





Figure 7: MSW Exports to NEWMOA States: 1999 through 2005 (tons)

1999 through 2005 (tons)**






2005 MSW Imports to Connecticut (tons)




2005 MSW Exports from Connecticut (tons)






2005 MSW Imports to Maine (tons)




2005 MSW Exports from Maine (tons)



MSW Imports to Maine: 1999 through 2005 (tons)




MSW Exports from Maine: 1999 through 2005








2005 MSW Imports to Massachusetts (tons)




2005 MSW Exports from Massachusetts (tons)




**MSW Exports from Massachusetts: 1999 through 2005






2005 MSW Imports to New Hampshire


2005 MSW Exports from New Hampshire




MSW Exports from New Hampshire: 1999 through 2005








2004 MSW Imports to New Jersey (tons)




2004 MSW Exports from New Jersey (tons)



MSW Imports to New Jersey: 1999 through 2005 (tons)








2005 MSW Imports to New York (tons)




2005 MSW Exports from New York (tons)



MSW Imports to New York: 1999 through 2005 (tons)







2005 MSW Exports from Rhode Island (tons)




MSW Exports from Rhode Island: 1999 through 2005 (tons)






