The Northeast Waste Management Officials' Association (NEWMOA) has partnered with the Northeast Interstate Water Pollution Control Commission (NEIWPCC) and the Northeast States for Coordinated Air Use Management (NESCAUM), the Northeast Recycling Council (NERC), and others to organize the second regional science conference on per- and polyfluoroalkyl substances (PFAS). The three-day conference will be held April 2-4, 2024 at the Best Western Royal Plaza in Marlborough, MA. The goals of the conference will be to:

- Ensure that local, state, and federal action to address PFAS contamination is informed by the most current and reliable science
- Facilitate networking and information-sharing among key stakeholders on PFAS topics
- Identify important gaps in the science and policy to help inform future research

The conference will take place over three days and will include plenary and concurrent break-out sessions and an exhibit and poster area. There will be ample time during the breaks for networking and viewing the exhibits. There will be a reception in the evening of the first and/or second days.

The conference organizers expect conference attendance to be 500 - 600 people. The invitees will include:

- Local, state, and federal government officials
- Academic researchers and students
- Consultants and vendors
- Companies that use, make, or sell products that contain PFAS
- Non-governmental and environmental organizations

Sponsoring the Conference

All sponsors will have high visibility prior to and during the Conference.
